Municipal Building Chattanooga, Tennessee October 28, 1997

The meeting of the Chattanooga City Council was called to order by Chairman Swafford with Councilmen Eaves, Hurley, Lively, Pierce, Rutherford and Taylor present; Councilmen Crockett and Hakeem were out of the city on business. City Attorney Randall Nelson, Management Analyst Randy Burns, and Council Clerk Carol O'Neal were also present.

INVOCATION

City Attorney Randall Nelson gave the invocation for the evening.

MINUTE APPROVAL

On motion of Councilman Lively, seconded by Councilman Pierce, the minutes of the previous meeting were approved as published and signed in open meeting.

SPECIAL PRESENTATION: RECOGNITION OF PARKS AND RECREATION DEPARTMENT - "HANGTIME"

Chairman Swafford stated it is a pleasure to recognize the Parks and Recreation Department's "Hangtime" key people, along with the collaborative efforts of the Police Department. He stated "Hangtime" was a program that came about as the result of the coming together of concerned persons in Parks and Recreation and administration to help find ways and activities to create positive activities for our youth this past summer. He stated this was a very successful effort and hopes it will continue; that many people pulled together toward the success of this project.

Chairman Swafford recognized Barbara Readnower, Jackie Moore, Kevin McGowan, Tom Boykins, Kenneth Simpson, Richard West, Gerald Cunningham, Mike Todd, Michelle Alexander and Aaron Hicks of the Recreation Department. He also recognized Chief Gloster, Captain Cooke and Sgt. Williams of the Police Department. (As each person's name was called Councilwoman Hurley presented them with a lapel pin bearing the City's Seal.)

SPECIAL PRESENTATION: RECOGNITION

Admin. McDonald stated this was a program that was really originated through Councilwoman Rutherford to help the youth in her district; that it was promised by the Mayor that a way would be found to solve the problem of youth not having anywhere to go to congregate. He stated these dedicated people along with fourteen other recreation staff, ten police officers, and twenty volunteers gave up five scheduled weekends to work this program; that they all did a tremendous job. He concluded his remarks by expressing appreciation to the Council for recognizing these persons.

SPECIAL PRESENTATION: INTRODUCTION OF RICHARD OTTAWAY OF THE BRITISH PARLIAMENT

Chairman Swafford stated Chattanooga's very special guest this evening is Richard Ottaway from the United Kingdom. He stated Mr. Ottaway's visit to the United States includes Washington, New York and Chattanooga; that the purpose for his visit is to look at the different forms and types of government. He stated we are extremely pleased to have Mr. Ottaway visiting with us and expressed a warm welcome to him on behalf of the Mayor and Council.

Jim Frierson of RiverValley stated Chattanooga continues to get an interesting stream of visitors who are either looking at the electric buses, affordable housing or others; that this visit is in reference to how a city of our scale functions and particularly how an elected Council and Mayor run a city. He stated Mr. Ottaway's visit to the United States will cover one-and-a-half weeks with his going to New York, Washington and Chattanooga; that his visit is part of the U.S. Information Agency's International Visitor Program. At this point he introduced Mr. Ottaway to the Council.

Richard Ottaway thanked the Council for inviting him and mentioned that this is his second visit to the United States; that he came in 1960 on the occasion of the Fourth of July and asked what everyone was celebrating! He stated the second visit was about ten years ago when the stock market "crashed"; that he must be bringing a jinx because there has been yet another stock market "crash" on this visit! He stated he is in Chattanooga to look at the City and its citizens' way of life, but in particular the way Chattanooga's affairs are run. He stated there is a a new form of government in Great Britain and a new form of local government is being proposed for London and he is the opposition spokesman.

Mr. Ottaway stated he is here to look at the way Chattanooga runs its affairs and interacts with others; how the Council works with the Mayor. He expressed thanks to the Council for being so hospitable.

Councilman Eaves stated he sometimes watches the television channel that televises the British Parliament in session and observed that everything is brought out in the open. Mr. Ottaway stated the telecast is a very good representation; that if a person opposes the government they are asked to sit on one side and if a person supports the government they are asked to sit on the other side.

Chairman Swafford again commented that Chattanooga is honored by Mr. Ottaway's visit.
