# CHATTANOOGA METROPOLITAN AIRPORT AUTHORITY:

Councilwoman Rutherford expressed her unfamiliarity with Carl Rawlings. Admin. Boney explained that Mr. Rawlings is associated with one of the carpet mills in Dalton and his appointment is part of the expanded Airport Authority Board structure to embrace a more regional concept to the airport.

#### **COMMITTEES**

Councilman Hakeem stated the Budget and Finance Committee met earlier today; that the Mayor gave an overview of preliminary discussions with the County Executive regarding the sales tax agreement. He stated the Mayor plans to come back to Committee possibily within the next two weeks to see if there is a plan being suggested by himself and the County Executive to put forth to legislative bodies.

Councilwoman Hurley reminded Council members of the Health, Education, Human Services and Housing Opportunities Committee scheduled for Tuesday, November 23 with Superintendent Register being present.

Councilwoman Rutherford stated a meeting of the Parks and Recreation Committee will be held Tuesday, November 23 at 4 p.m.

# **COMMITTEES (Continued)**

Councilman Taylor stated a **Safety Committee** was previously scheduled for Tuesday, December 7 and there is a need to change the date to **December 14 immediately following the Public Works Committee.** 

#### DR. GRACE HEWELL

Dr. Grace Hewell stated she is a resident of Chattanooga, Tennessee and is present asking for a point of information about policies and procedures. She asked how community residents' concerns are addressed by the Council and whether they are limited entirely to committee action. She asked what the procedures are in the way concerns are handled, as well as how policy issues are handled. She stated she would like to give a status report that the Hamilton County Board of Commissioners took a position in support of the preparation of our citizens' request for a proposal on environmental education. She stated they are pulling together a group of people and suggested that there be a joint position paper with the City Council and the county agreeing to whatever takes place because we are moving close to cooperation with many counties, and such a proposal would not be limited to no particular neighborhood but a more comprehensive approach to education. She stated she earlier distributed information regarding the definition of envirohmental education; that education is not limited to children and youth, but more comprehensive toward planning. She stated the issue involves two committees of the Council.

Councilman Hakeem stated that the Council has expressed to Dr. Hewell on more than one occasion that the matter has been put into Councilman Crockett's committee; that she has been asked to contact Councilman Crockett to see if it can be placed on his committee's agenda. He asked for clarification of the two committees Dr. Hewell referenced.

Dr. Hewell stated the committee is Health and Education; that education is certainly an issue and the health of people is covered by another committee. She stated that she did speak with Councilman Crockett, who is amenable as soon as a committee can be arranged; that she might not be present but is sure people from the county would meet with whomever Councilman Crockett wants to meet with. She stated it is her hope there will be a meeting before the year 2000.

Councilwoman Hurley stated the Council did suggest that the matter go before Councilman Crockett's committee; that she thinks Dr. Hewell has a number of issues. She stated that the Council referred the request to the City's Grants Division, which she thought originally was that the Council apply for a grant; that the Grants Division reviewed it and indicated we really just did not have the capacity to manage that grant. She stated we do not run the schools system and knows Dr. Hewell is talking about an adult program, as well.

## **DR. GRACE HEWELL (Continued)**

Councilwoman Hurley continued by stating that she is trying to be as honest and straight forward as she can; that the Council does not have the staff capacity to run an education program and environmental education program; that we can have an economic development committee meeting and discuss this if that is all that is required. She stated it is not within the Council's function, in her opinion, to apply for and administer the grant; that a few weeks ago she informed Dr. Hewell that the Council could not do that and would be stepping outside what the Council's legitimate responsibilities are. She stated this conversation has been held a number of times and thinks it would be a misrepresentation if we promise we could apply for a grant, administer the grant and educate the adults in this community. She stated we simply do not have the capacity.

Dr. Hewell stated she deals with policy formulation and decision-making; that she is talking about guidance. She stated there is a break in communication when these grants are awarded; that she is personally very proud of the cooperation of this Council and of Chattanooga; that Tennessee is the third state to get environmental justice legislation in the United States. She stated many of the questions and issues can be handled by dialogue with the county, but if the Council does not want to participate that is a decision of the Council.

Councilwoman Hurley stated she would only say it is not an issue whether we wish or do not; that the fact is the county does have responsibility for public health in this community and for education. She stated she does not think she and Dr. Hewell should debate the matter here, reiterating that the conversation has taken place before and thinks it is important that each branch of government understand what its responsibility is.
