Chairman Hakeem called the meeting of the Chattanooga City Council to order with Councilmen Benson, Franklin, Littlefield, Lively, Page, Pierce, Robinson, and Taylor present. City Attorney Randall Nelson, Management Analyst Randy Burns, and Shirley Crownover, Assistant Clerk to the Council, were also present.

**PLEDGE OF ALLEGIANCE/  
INVOCATION**

Following the Pledge of Allegiance, Councilman Page gave invocation.

**MINUTE APPROVAL**

On motion of Councilman Littlefield, seconded by Councilman Franklin, the minutes of the previous meeting were approved as published and signed in open meeting.

**REZONING**

Ms. Sloan offered a thank you to one and all for the contribution made to Westside. She stated that she would take a few minutes to talk about the progress they were making and to boast. She stated that Westside had been given \$4 million dollars in federal funding for economic development and were now starting with another project. This fifth project is in the neighborhood of \$1 million dollars and will be a Health and Wellness Program, and they are choosing to move the facility to a place that will be able to create jobs in the community and will offer health awareness and nutritional advice for senior citizens who call this area their home. She stated that they had figured out for every dollar granted, they had in fact matched with federal dollars at the rate of 2 and one-half times. She stated that they were good stewards and were able to attract federal dollars.

Chairman Hakeem thanked Ms. Sloan for the work she had done, stating that all can see the good that is coming out of this.

He stated that they had met several times with the Mayor and had framed the scope of study and would be naming a chairperson in the near future. They are now at the 90-day mark.

Councilwoman Robinson announced that there would be a North Chattanooga Neighborhood Association Meeting on November 29<sup>th</sup> at the North Side Presbyterian Church. She also stated that a Parks and Recreation Committee meeting was held earlier in the day, and it was discussed that they had been contacted by Amos Baker who wished to have a monument placed at the Carver Recreation Center to commemorate work he had done for them. She stated that we are blessed in Chattanooga that we have so many people who are willing to help and that it would be impossible to have this kind of recognition for each individual and unfair to single out any one person for this type of recognition. She expressed her sincere thanks to everyone for making Chattanooga a better place to live.

Councilman Taylor announced that there would be a District 7 Christmas Party to be held at Chattem Drugs on W. 38<sup>th</sup> St. on December 10<sup>th</sup> at 6:30 P.M. He invited all department heads to come, stating that it would be an exciting time, and he extended an invitation to all neighborhood leaders and city workers.

Chairman Hakeem announced that there would be a Glenwood Planning Staff Meeting at the Glenwood Recreation Center on Thursday, November 29<sup>th</sup> at 6:00 P.M.
