Chairman Littlefield noted that since last week the Council had had an opportunity to review this. COMMITTEES

Councilman Benson reminded the Council of the **Legal and Legislative Committee meeting scheduled for Tuesday, March 11th at 3:00 P.M.** The topics of discussion will be "Spaying and Neutering" and the Pawn Shop issue.

Councilman Franklin reminded the Council of the Safety Committee meeting scheduled for Tuesday, March 18th immediately following the Public Works Committee meeting.

Councilman Hakeem reminded the Council of the **Public Works Committee meeting scheduled for Tuesday, March 18th at 4:00 P.M.** He also mentioned Juliette Thornton at 7:00 P.M. tomorrow in regards to Mrs. Rogers.

Councilman Lively asked Adm. Eichenthal if he needed a Budget and Finance Committee set. He did not and a meeting was not scheduled.

REZONING MATTER 153 AND SUTTON DR.

Councilman Lively brought to the Council's attention that last September there was a rezoning request to C-2 at H/W 153 and Sutton Drive; that a month and half ago Jeff Carmack brought before the Council an O-1 Zoning and request for a waiver of 9 months, and the Council voted "no". Councilman Lively stated that he had met with the neighborhood and Mr. Carmack and that Mr. Carmack and the neighborhood are requesting the corner lot being rezoned to O-1. He stated that he would like to settle this situation once and for all; that he had not had a chance to talk to the City Attorney about this.

Chairman Littlefield stated that he would tend to agree with Councilman Lively about settling this issue if we could find a way to do this; that he had wrestled with the same issue in 1988, and it had gone full circuit. He questioned if it were turned down for C-2 if they could come back asking for O-1.

Attorney Nelson explained that the Council can refer this to the Planning Commission, and it can come back within the normal circuit. **Councilman Lively moved that this be referred to the Planning Commission,** stating that he thought it was common sense; that this neighborhood is elated that this gentleman is willing to develop the whole thing.

Councilman Benson suggested that before it goes to the Planning Commission that Mr. Carmack present renderings, a site plan, and the conditions that the people from the area have agreed upon. He stated that we needed this all down so that there would be no speculation. Councilman Lively noted that Mr. Carmack had agreed to the buffer. Councilman Benson stated that if he would come in with good renderings and a site plan that he would second Councilman Lively's motion to refer this to the Planning Commission.

Attorney Nelson explained that we would be referring one lot back to Planning as Case # 2003-024 Jeffrey Carmack comes before the Council next week.

Councilman Littlefield added that it takes two months for this to get back to the Council and this involves the northern lot of Sutton Drive.

COMMITTEES (CONT'D.)

Councilman Page indicated that he would like to schedule an **Economic Development Committee meeting for March 18th.** Ms. Crownover informed Councilman Page that there were already three committee meetings scheduled for that date. Councilman Page asked her to get with Mr. Traughber to schedule a suitable date. (After the meeting Ms. Crownover contacted Mr. Traughber. An **Economic Development Committee meeting was scheduled for Tuesday, March 25th immediately following the Parks and Recreation Committee meeting.**

Councilman Pierce stated that the **Committee Of-The-Whole meeting** scheduled for next Tuesday would not meet as there is nothing to talk about and he had asked that Mr. Burns relax his mind and regroup; that when there are more plans to be presented, he will call a meeting later. In the meantime, this meeting has been cancelled indefinitely.

Councilman Taylor noted that the meeting set for **Health, Education, Human Services and Housing Opportunities** scheduled for earlier today to discuss air quality would have to be rescheduled; that Ms. O'Neal was working on this, and it needed to be refined and fine tuned, and the meeting would be announced later on.
