City Council Building Chattanooga, Tennessee September 21, 2004

Chairman Benson called the meeting of the Chattanooga City Council to order with Councilmen Hakeem, Littlefield, Lively, Pierce, and Page present. Councilmen Franklin, Robinson and Taylor were out of the City. City Attorney Randall Nelson, Management Analyst Randy Burns, and Shirley Crownover, Assistant Clerk to the Council, were also present.

PLEDGE OF ALLEGIANCE/ INVOCATION

The Pledge of Allegiance was led by Councilman Littlefield, followed by invocation.

MINUTE APPROVAL

On motion of Councilman Lively, seconded by Councilman Littlefield, the minutes of the previous meeting were approved as published and signed in open meeting.

AMEND ZONING ORD. BOARD OF APPEALS

On motion of Councilman Page, seconded by Councilman Pierce, AN ORDINANCE TO AMEND ORDINANCE NO. 6958, AS AMENDED, KNOWN AS THE ZONING ORDINANCE, BY AMENDING ARTICLE VIII, SECTION 108(2), RELATIVE TO TIME LIMIT CONFIRMATION FOR BOARD OF ZONING APPEALS DECISIONS

passed second reading. On motion of Councilman Littlefield, seconded by Councilman Lively, the Ordinance passed third and final reading and was signed in open meeting.

REZONING

(2004-154 Pete Cory)

On motion of Councilman Lively, seconded by Councilman Littlefield, AN ORDINANCE TO AMEND ORDINANCE NO. 6958, AS AMENDED, KNOWN AS THE ZONING ORDINANCE, SO AS TO REZONE A TRACT OF LAND LOCATED IN THE 1700 BLOCK OF JOINER ROAD, MORE PARTICULARLY DESCRIBED HEREIN, FROM R-1 RESIDENTIAL ZONE TO R-2 RESIDENTIAL ZONE, SUBJECT TO CERTAIN CONDITIONS

was substituted. On motion of Councilman Littlefield, seconded by Councilman Lively, the Ordinance passed second reading. On motion of Councilman Lively, seconded by Councilman Page, the Ordinance passed third and final reading and was signed in open meeting.

REZONING

(2004-160 Joe Sliger)

On motion of Councilman Littlefield, seconded by Councilman Lively, AN ORDINANCE TO AMEND ORDINANCE NO. 6958, AS AMENDED, KNOWN AS THE ZONING ORDINANCE, SO AS TO REZONE TRACTS OF LAND LOCATED AT 1635 AND 1639 ROSSVILLE AVENUE, MORE PARTICULARLY DESCRIBED HEREIN, FROM M-1 MANUFACTURING ZONE AND R-3 RESIDENTIAL ZONE TO C-3 CENTRAL BUSINESS ZONE, SUBJECT TO CERTAIN CONDITIONS

was substituted. On motion of Councilman Pierce, seconded by Councilman Lively, the Ordinance passed second reading. On motion of Councilman Littlefield, seconded by Councilman Page, the Ordinance passed third and final reading and was signed in open meeting.

Councilman Pierce inquired as to what the substitution was for. Mr. Pace explained that the language for parking had been removed.

AMEND CITY CODE MOVING OF BUILDINGS

Councilman Littlefield noted that this came before the Legal and Legislative Committee with a recommendation for approval.

On motion of Councilman Littlefield, seconded by Councilman Lively, AN ORDINANCE TO AMEND PART II, CHATTANOOGA CITY CODE, CHAPTER 10, ARTICLE I, SECTION 10-3(e), RELATIVE TO MOVING OF BUILDINGS passed first reading.

Attorney Nelson made mention of some slight changes, including individual properties having a blighting influence as opposed to the whole neighborhood.

REZONING

(2004-159—Richard Volz)

Councilman Littlefield stated that this was discussed briefly in the Legal and Legislative Committee meeting, and the owner wishes to withdraw this petition.

On motion of Councilman Littlefield, seconded by Councilman Lively, AN ORDINANCE TO AMEND ORDINANCE NO. 6958, AS AMENDED, KNOWN AS THE ZONING ORDINANCE, SO AS TO REZONE A TRACT OF LAND LOCATED AT 2332 STANDIFER GAP ROAD, MORE PARTICULARLY DESCRIBED HEREIN, FROM R-2 RESIDENTIAL ZONE TO C-2 CONVENIENCE COMMERCIAL ZONE was withdrawn.

Councilman Pierce noted that there was no opposition present. Chairman Benson added that the applicant had called him about this also.

AMEND CITY CODE TIMBER REMOVAL ORD.

Mrs. Beverly Johnson stated that this Ordinance is okay to approve on first reading but that there were three issues that Adm. McDonald had and that he was out of town; that one of the issues dealt with the Bond; that he wants to make sure his issues are covered before this is passed on second and third readings.

Councilman Littlefield stated that he believed at least two of these issues had been addressed and that the Council had decided to delay second and third readings for three weeks until all have had a chance to review it and to be sure that everyone is on the same page.

On motion of Councilman Littlefield, seconded by Councilman Hakeem,

AN ORDINANCE TO AMEND PART II, CHATTANOOGA CITY CODE, CHAPTER 31, BY ADDING NEW SECTIONS 31-325.1 THROUGH 325.9 KNOWN AS THE TIMBER REMOVAL ORDINANCE AND BY AMENDING SUBSECTIONS 31-321(b) and (c)

passed first reading.

TAX AGREEMENT

Councilman Page noted that both Resolutions (a) and (b) had been discussed in a joint Legal and Legislative/Economic Development Committee meeting and come with a recommendation for approval.

Attorney Alfred Smith informed the Council that the caption read "INDUSTRIAL DEVELOPMENT BOARD OF THE CITY OF CHATTANOOGA" and it should be "INDUSTRIAL DEVELOPMENT BOARD OF THE COUNTY OF HAMILTON". This was changed by Attorney Nelson in open meeting. Mr. Smith explained that Regis Corporation bought their property through Hamilton County and TMIO chose the County so that they could go in tandem and have only one meeting. It was pointed out that this also reduces the legal fees. Councilman Littlefield stated that he recalled seeing the documentation that said Industrial Development Board of the County of Hamilton.

was adopted.

COMMITTEES

Councilman Littlefield reported that the Legal and Legislative Committee met today and approved several items brought by the Personnel Dept., including continuation of an Insurance Program for older retirees, sometimes called the "Untouchables"; the Plan will not change and is managed by Claritan Co., who will continue to manage it. At the meeting next week there will be a follow-up to changes in the personnel structure for exempt and non-exempt services. The Legal and Legislative Committee will meet, as usual, on **Tuesday**, **September 28**th at 3:00 P.M.

Councilman Hakeem reminded everyone that the **Public Works** Committee will meet next Tuesday, September 28th at 4:00 P.M.

SISTER BEY

Sister Bey approached the podium, stating that the Council knew who she was; that she wanted to come before the Council before she wrote to Colin Powell, asking him how he plans to impress the people in East Africa. She spoke of the way her people were being treated with their cars and property being seized, stating she would not let anyone crush her people's spirit. She went on to say that their birthright had been stolen and that it was bad when her people tried to destroy each other. She stated that she would not let Colin Powell think he is getting away with what he is doing; that it is tough to clean up our own house. She stated that she did not "go" for a God who demands a blood sacrifice and ended by saying some of the Council had not returned her calls and that she did not appreciate it.

CARL EPPERSON

Carl Epperson of 500 W. MLK Blvd. Addressed the Council and thanked them for letting him come before them and voice his concerns. He stated that he addressed the Council last Spring about streets not being cut for wheelchairs and was asked to call 311 and write a letter to the Department of Public Works. He stated that he could not get through to 311 and had sent a letter to Public Works but had not heard anything.

CARL EPPERSON (CONT'D)

Chairman Benson noted that both Naveed Minhaus, City Engineer, and David Eichenthal, who heads up 311, were present tonight and asked Mr. Minhaus to talk with Mr. Epperson after the meeting.

Mr. Epperson also wanted to know if there was going to be a hotel in Coolidge Park. Chairman Benson responded that that is what the newspapers say. Mr. Epperson stated that this would be a total fiasco—putting a hotel in Coolidge Park. He questioned why we needed another hotel and stated surely there would be a more suitable place than a public park; that this was insane—just like the two-way street issue. He went on to say that like the two-way street issue, citizens should be allowed to vote on whether or not they wanted a hotel; that our last two Mayors had seen a "Field of Dreams"—thinking if we build it "they will come".

Chairman Benson told Mr. Epperson that a Public Hearing was to be held concerning the Hotel and that it had been postponed until the third Thursday in October, and he encouraged him to attend this meeting.

TONY GREEN

Tony Green of Francis Drive addressed the Council, discussing a stormwater drainage problem. He asked Chairman Benson if he remembered him, telling him that he did what he had been told to do and talked to those he was told to talk to; that he was now sitting with a foot of water in his house, and the developer had not left the required 25 foot buffer and the trees and water was coming down twice as fast, and he was flooded. He stated that Stormwater Drainage did come out and capped some sewers, but it was still seeping.

Chairman Benson asked him if he was contesting that the developer had increased the water on him

Mr. Green responded that when he raised it, it would be five or six feet and that Chairman Benson told him it would be taken care of.

Councilman Benson asked Public Works who was responsible for this and what would be done; that this man had been here previously, and we appreciated him coming.

TONY GREEN (CONT'D)

Mr. Payne of Stormwater stated that they sympathized with Mr. Green's problem and when he talked with Mr. Green he told him that there was a lot of development in his area and much of this development was before stormwater regulations were enacted, and they planned to make sure what was being proposed would not create worse problems for him; that they had met with the present owner and his engineer to talk about what is best for this area.

Councilman Littlefield stated that he was concerned because it appears that the developer has already violated the agreement to have a buffer area and the trees; that he did the bare minimum; that this was a nasty and raw looking area and hoped that it would be improved before we had another such event—that Hurricane Opal that did so much damage in the past came late in the season. He stated that he hoped Stormwater would get with the engineer who is working on this development and our engineers should look at the sanitary sewers and line them; that the problem is that the manholes need to be raised and a number of things need attention. He stated that we sympathize with Mr. Green; that he had talked with Harold Coker, who lives near Mr. Green, and he was blocked because Standifer Gap was under water at both ends. He stated that we got more than the reported 6"; and he suspected it was more than the flood in May.

Mr. Green stated that when he raises this up 4 ft. that only a sprinkle of rain will cause a gigantic pond; that a good heavy rain will do this again.

Councilman Littlefield agreed that the developer had gone beyond what he agreed to do.

Mr. Green added that Mr. Minhaus had suggested that he raise his house up.

Chairman Benson stated that he thought we were assured by our engineers when this was rezoned that this would not happen; that this could go in without creating problems.

Mr. Green stated that he thought the City needed new engineers!

Chairman Benson asked Public Works if we were doing everything that we assured Mr. Green that we would do.

TONY GREEN (CONT'D)

Mr. Green stated that Mr. Minhaus told him that they could not do anything about this other than having Mr. Green raise his house.

Mr. Payne stated that everything was done in accordance with the Stormwater Ordinance.

Chairman Benson still contended that Mr. Green was not supposed to have had additional water.

Mr. Payne stated that the developer had not submitted his final set of plans for the clearing of trees; that they were getting with Zoning Officials to work with them on the buffer issue.

Mr. Green stated that this looked like "a plucked chicken" now.

Chairman Benson asked Mr. Green if he would be able to get off from work to come to the Public Works Committee meeting at 4:00 P.M. next Tuesday; that we should know more about this then and we will see what can be done to mitigate the problems. He thanked Mr. Green for coming.

ADJOURNMENT

Chairman Benson adjourned the meeting of the Chattanooga City Council until Tuesday, September 28th at 6:00 P.M.
