He stated the ordinance updates our open burning regulations in Chattanooga and other regulations consistent with complying with new federal regulations; that this keeps us from getting into federal trouble – or more federal trouble!

ADOPTION OF THE 2004 DOWNTOWN PLAN

Karen Hundt, Director of Comprehensive Planning at the Design Center, introduced staff members present who worked on the Plan – Stroud Watson, Pat Sutherland, Christian Rushing, Pam Glaser, Sabrina Carlson, Barry Bennett and Jerry Pace. She stated Jim Kennedy is also present and worked with them in the area of consulting and noted that Ms. Carlson's employment began this past Friday and (she) would be working with the historic zoning districts.

ADOPTION OF THE 2004 DOWNTOWN PLAN
(Continued)

At this point a fourteen minute video detailing the Plan was shown to everyone in attendance.

At the conclusion of the video Councilman Littlefield stated that the Plan was discussed before the Legal and Legislative Committee several weeks ago and passed with a recommendation for approval. He stated Chancellor Richard Brown is in the audience to address the proposal for Vine Street, which is one of the items in the Plan that led to some discussion. He stated any folks present on that issue might know this was an issue some years ago when he (Littlefield) was previously on the Council; that he is surprised to see it in this Plan and had many calls about it. He stated he has been advised that since the matter was addressed some years ago, the street was legally closed and abandoned and it is, therefore, the University's responsibility to make any changes in regard to Vine Street; that the city cannot unless we take the University to court and he does not see that happening under any circumstance. He stated that issue does not require a great deal of concern. He stated there was talk at Planning that the language has been "softened" as it relates to Vine Street and asked Karen Hundt if it has been rewritten.

Ms. Hundt stated that it has been rewritten since the initial discussion with the University and Fortwood about the future of Vine Street as it relates to pedestrian safety and the overall street circulation system in the downtown area.

Councilman Littlefield stated that many communities are finding that closed off malls have not worked well in terms of security and did not accomplish what was noted by author Jane Jacobs in her book *Life and Death of Early American Universities*; that there was limited but calm traffic and it is his belief that it is something the University should consider and it is up to the University to do that. He stated the only campus he has seen so completely cordoned off was Kent State in Ohio, which we understand what led them to putting a perimeter around the campus and it continues to be that way. He stated he has driven across many campuses and the one most notable was in Portland where gates closed the street during the day when students were present and opened after hours for limited traffic through the campus. He stated it is his hope the University will consider that; that it is up to them to take action in that regard. At this point he **made the motion to adopt the resolution.**

Councilman Hakeem asked for a point of clarification from City Attorney Nelson and inquired if the statement by his colleague (Littlefield) in regard to this being an issue that can only be brought by the University is the case.

ADOPTION OF THE 2004 DOWNTOWN PLAN
(Continued)

City Attorney Nelson stated that he did not recall that it had been abandoned a number of years ago; that it was temporary and then it became permanent. He stated if it was closed and abandoned several years back to owners of the University since they own both sides of the street. He stated it is like there is no street there now and if it is reopened we would have to see if we could exercise our power of eminent domain, which would seem unlikely.

Councilman Hakeem asked Ms. Hundt if there has been any study or review of arterial streets since the two-way change became effective and how it is working out.

Ms. Hundt stated that in going from one-way to two-way, Traffic Engineering keeps traffic counts on accidents and other information and it is her thought some type of report would be available for the Council after the first of the year.

Councilman Hakeem asked what the interest in opening Vine Street is based on if there is no data to look at.

Ms. Hundt stated that it is really based in principal on the idea of needing as many options as possible in downtown for people of all age groups to get around. She stated there is a grid of streets and that grid allows traffic to be dispersed through all streets evenly; that if one is closed or cut off, it forces some of the traffic that would be on those streets to others street and end up with too much traffic on the other street. She stated it is about even distribution of traffic.

Councilman Hakeem asked what consideration has been given in regard to safety.

Ms. Hundt stated none of this has been decided or "set in tone"; that they could physically change the character of the street by putting in pavers with stamped concrete crosswalks downtown and on-street parking to narrow the street a little, things that force motorists to slow down coming through.

Councilman Hakeem stated if he understands correctly it is not that there is a need for it but an option the Plan would like to have.

Ms. Hundt stated that the Plan is a set of principles and goals they hope will guide decisions for a number of specific recommendations, but recognize some will change over time. She stated reopening Vine Street goes to the principle of having multiple options and a way for people to get around downtown.

ADOPTION OF THE 2004 DOWNTOWN PLAN
(Continued)

Councilman Hakeem stated in reference to the restatement of that piece in regard to Vine Street, in approving this Resolution would it infer that the Council is in favor of reopening Vine Street.

City Attorney Nelson responded that he did not think so; that there would just be more discussion.

Councilman Page stated that he understands Vine Street is a University issue as opposed to a Council issue. He stated he wanted to take a moment to thank the staff that worked on this plan; that he has been a lifelong resident of Chattanooga and could not be more proud of the downtown area and what is going on. He stated plans like the North River Plan and other parts of the city are planning tools to be used as a road map for the future. He stated that he was helping recruit someone and took them to the downtown area to see what is going on and they really got excited; that this is a tremendous spin-off of what is going on and extended a special thank you to the RPA staff that put the Plan together. At this point he **seconded Councilman Littlefield's motion to adopt this Resolution.**

Councilman Pierce addressed Mr. Brown and indicated that he was happy that things turned out in the University's favor. He stated he has always proposed keeping it open from "day one"; that it will be left in the Plan for the future and hopes some day the University will realize we are talking about the danger to students. He stated at the time it was closed there was full activity at McClellan Gym and since that time activity has ceased (at the gym). He stated he can not foresee any more traffic crossing Vine than crossing McCallie from the M. L. King area; that he hopes the University will not decide in the future they might need to close McCallie down to make another connection with the campus!

Councilman Taylor expressed thanks to everyone that worked diligently on the Plan. He stated there has been a lot of discussion regarding the University and asked Mr. Brown to comment.

Richard Brown stated he was present on behalf of the University, indicating that it appeared the Council was "bashing" the University! He stated over the last ten years there has been a great partnership and indicated this is a wonderful plan and UTC is proud to be the City's University as it has Chattanooga's name on it. He stated the closure of Vine is not a closure and wanted that to be made part of the records as it was some nine years ago when he said to Councilman Littlefield that the University was only closing about 300 feet of the street.

ADOPTION OF THE 2004 DOWNTOWN PLAN
(Continued)

Mr. Brown stated that the University still has great access east and west to all parking lots and facilities in the area. He stated over the last six years the streets adjoining the University have benefited from the two-way and is working very well; that Fourth Street has a connector to the two-way and is working very well and the University supported those changes. He stated as far as the Plan is concerned the University is building in a manner that is consistent with urban planning as they are building up to the sidewalk and contributing to the residential life of the community and referenced the University's \$17 million renovation.

Mr. Brown stated the closure does not represent a hazard to vehicular and pedestrian traffic and clarified that McClellan Gym has multiple uses. He stated that the campus is growing and is one of few within the UT-system that will grow to 12,000 over the next five years and they are very proud of that. He stated in the spring demolition of the north stadium dorm will begin and the addition of a wonderful green space will be brought back to the "heart" of the campus for outdoor gatherings. He referenced that ten acres would be opened up in the "heart" of the campus for new development, academic space and a new outdoor cultural space with an art focus. He stated the University has no intent of closing off the University to anyone as there is great access, landscaped parking and a lot consistent with the Plan. He stated he loves the notion of outdoor space and art and infusing those dimensions into the University.

Mr. Brown concluded his comments by stating that there might continue to be some dialogue about opening of that street when there is pedestrian and vehicular conflict, indicating he would like to be a part of the leadership and collaboration in working with Ms. Hundt and the Urban Design Studio. He stated that it is his thought the University is a good city partner and as the city's University they are proud to be a player in the downtown plan.

Councilman Taylor inquired if Mr. Brown has any problem with the wording in the plan.

Mr. Brown responded that the University is evolving and has no problem with the wording. He stated that this was the first time he had seen the video and it was delightful, again expressing his appreciation for the work on the Plan.

Councilman Littlefield thanked Mr. Brown for his statement and expressed that it was his thought it was not the Council's intent to sound as if they were "bashing" the University; that they want the best for the University.

ADOPTION OF THE 2004 DOWNTOWN PLAN
(Continued)

Councilman Hakeem stated that it is relevant for Mr. Brown to make the comments he made as he pointed out that the University has not, is not and never will be an obstruction with what the community is trying to do. He expressed agreement that the University has been a good partner.

Chairman Benson encored Councilmen Littlefield and Hakeem's comments and expressed that he was sorry if Mr. Brown perceived it as that (University "bashing").

Stroud Watson, Director of the Design Center, stated that it is his thought this is a remarkable piece of work that was some 24 years in the making and every single person in the Assembly Room in some way contributed to that. He stated it is important to note that it is a little disturbing that this single issue would come out of something that is really about the future of our city and how to get from the past into the present and into the future based on a set of principles. He stated systems have to be integrated in every decision we all take and based on goals which will change and manipulate over the years. He stated the intent of having more specific comments to point out areas facing us today that we can see might improve conditions. He stated one of the goals of the University that has grown stronger and stronger over the last ten years is the connection downtown to the campus and the campus to downtown. He stated this is one of the ways to help do that; that there are lots of ways to open and manipulate streets to take care of pedestrians. He stated the other point is to raise those questions and put the principles, goals, and those systems into a light which we can collectively make decisions for our future. He stated what this has done for the City is to make it more visible to everyone and what we have come to understand helps make a great downtown, makes us create and continue to make decisions that respond to all citizens and set goals that are integrated and allow us to have the proud, wonderful city we have.

At this point, Councilman Franklin "called for the question" on the motion to adopt this Resolution.
