HEARING: SABRINA L. SMITH

City Attorney Nelson reported that a request for an appeal was received from Sabrina L. Smith regarding her termination from the Chattanooga Police Department.

A hearing for Ms. Smith was scheduled for Monday, February 7 beginning at 3 p.m. with Councilmen Benson, Lively and Littlefield serving as the panel hearing the request.

COMMITTEES

Councilman Littlefield scheduled a meeting of the Legal and Legislative Committee for Tuesday, January 11 at 3 p.m.

ATTORNEY WALTER WILLIAMS

Attorney Walter Williams indicated that it was his thought there would be a discussion regarding police department promotions as he is concerned and had received calls regarding it; that he has learned the matter would be held until other Council members could be present. He stated that he would like to be a "party" in the discussion of the matter and would speak with Chief Parks as it is only fair to talk to him before saying anything further.

Chairman Benson indicated that he did not know when it was exactly scheduled; that it could be next week.

ANN WILLIAMS

Ann Williams of 618 Terrell Street stated that she is present because of the way certain ordinances are handled in the City. She stated that she had received a summons about unimproved property she owns that she plans to improve as soon as she could get it high enough above the flood plain.

ANN WILLIAMS (Continued)

Ms. Williams stated that she was summoned to court and Judge Williams was present on that day; that the inspector was told to go out to the property in question to see what the problem was. She stated luckily the inspector's supervisor come out and found no violation, but she had to go to court and pay court costs. She stated that it is her thought there is a problem in how ordinances are handled by the city inspectors or people charged with handling them that this Council puts into effect. She stated that she has property at 1144 Garfield and had a tenant who had no regard for what was thrown in the yard; that she talked with him and had someone pick up the trash. She stated he continued to do that and other things were happening and she had to wait long enough to give him a chance to violate the lease and when that failed almost at the same time she received a notice regarding "littered property".

Ms. Williams stated that a letter was sent and she worked with Ed Ram in Codes and worked it out. She indicated that the tenant no longer lives there. stated that she was not sure if he left trash on the sidewalk as he moved from the property because she did not see it as she was in the hospital, yet she received a summons saying that there was an "unscheduled set-out". She stated prior to the fourteenth of December she was on her way back from the Doctor and saw the trash on the street and thought that the tenant maybe put it out there however, she did not know at the time that he had moved. She stated she called 311 and was told they could only pick up eight items at a time and that she had to give a list of items on the street. She stated that she told them she did not have that information and would call them back. She stated after that time she received a summons to appear on January 10 due to an "unscheduled set-out" and indicated she would have to pay another court cost. She stated that she called Hubert Parry and asked him about it and he told her he sent the notice to her address at 517 Terrell; she informed him that she does not live at 517 Terrell; he indicated that he checked the tax rolls.

Ms. Williams continued by stating that she asked for a copy of the ordinance because Mr. Parry told her he was trying to follow the City Council's rules and was then told he did not have a copy of it. She stated that she called Rick Cooper, one of the supervisors, and asked him for a copy of the Ordinance and he indicated he did not know. She stated that she then called the Council office and the people in the office were very nice and instructed her as to how to navigate the website to get the ordinance. She stated as of today she has not received a copy of the ordinance and if she is guilty of something and violated anything she has a right to know what the ordinance says. She stated that it is her belief this Council should look into how these rules are taken care of and as a tax payer she feels she should have this service; that her property is not a multifamily complex it is a single-family dwelling.

ANN WILLIAMS (Continued)

Ms. Williams concluded her comments by stating that she is being made responsible for what someone else has done and no one wants to be responsible for what someone else does. She asked the Council to look into this and that she would like to know the results.

Chairman Benson stated what Ms. Williams has related comes under the area of Neighborhood Services. Ms. Williams clarified that her notices were from Citywide Services in Public Works.

Chairman Benson stated Admin. McDonald is present and could meet with him following tonight's meeting in an effort to resolve the matter. He stated if it is not resolved she should contact her Council person.

Ms. Williams indicated that she lives in Councilman Franklin's district. She stated that she wanted to make it known that people need to know how to talk to others; that if the ordinance adversely affects people it needs to be looked at as it is not fair for her to take her time to go to court for something another adult did; that that person is not her child! She stated it was not on her property as the trash was on the sidewalk and she does not know if he did it or not; that trash is all over and this is a serious problem. She stated the elderly do have the money to pay people to take trash out and they cannot put eight items out and call them to come back to pick up eight more items; that it is a waste of time and fuel.

Chairman Benson explained to Ms. Williams that the Council is the legislative body of the government and the Chief Administrator of Public Works is present and she should talk with him.

Ms. Williams stated that the Council should know when someone talks to various offices in the City they are always told the "City Council did this".

Chairman Benson adjourned the meeting of the Chattanooga Council until Tuesday, January 11, 2005 at 6:00 p.m.
