CITY COUNCIL BUILDING CHATTANOOGA, TENNESSEE MARCH 8, 2005

Vice Chairman Robinson called the meeting of the Chattanooga City Council to order with Councilmen Franklin, Hakeem, Littlefield, Page, Pierce, and Taylor present. Councilmen Benson and Lively were absent due to other commitments. City Attorney Randall Nelson, Management Analyst Randy Burns, and Assistant Clerk to the Council, Shirley Crownover, were also present.

PLEDGE OF ALLEGIANCE/ INVOCATION

Following the Pledge of Allegiance, Councilman Page gave the invocation.

MINUTE APPROVAL

On motion of Councilman Franklin, seconded by Councilman Littlefield, the minutes of the previous meeting were approved as published and signed in open meeting.

ALBANIAN DELEGATION

Vice Chairman Robinson announced that there was a group of Albanians who were visiting with the City Council and the Mayor; that they had not arrived yet but might come later to review our procedures at Council meetings; that they had been in Tennessee a couple of days to observe and had also visited Seattle and then would go to New York; that if they came in later, we would recognize them at that time.

AMEND ZONING ORD./PUD'S

Mr. Jerry Pace, Operations Director with RPA, explained that this is to correct the Zoning Ordinance in regards to the Preliminary Planned Unit Developments. As it stands, all structures are included in the Preliminary Plat, and this excludes free-standing single family structures, and is merely a housekeeping matter.

Mr. Pace of RPA explained that there is one correction needed; that the agenda failed to list the R-2 Zone. He noted that this had already been presented to Council committee but noted that they had Staff present for a further presentation if needed.

On motion of Councilman Taylor, seconded by Councilman Pierce,

passed first reading.

Councilman Taylor thanked the Staff and the Regional Planning Agency for all of their hard work and the way they had worked with the neighborhood, stating that he appreciated their support.

Councilman Littlefield added that this had been heard at the Legal and Legislative Committee and passed there. He asked if there was anyone present who was for or against this that would like to speak before the vote was taken, noting that this is a State Law.

REZONING

(2005-004) Erwin Marine Sales, Inc.

Pursuant to notice of public hearing, this case came on to be heard. Mr. Jerry Pace, Operations Director with RPA, made the presentation. He stated that this was in the Hixson area; that this had been before the Planning Commission for rezoning to R-1 and R-T/Z and did have deed restrictions, which TVA has lifted. This is a vacant area along Gann Store Road; that he thought the applicant and the neighbors had come to an agreement, and the rezoning does come with a recommendation from the Planning Commission and the Staff.

Councilman Page stated that there had been a lot of discussion about this; that the neighborhood and developer had come together with a compromise, and he would like to give the neighborhood and the developer a chance to state what they had agreed to; that the developer had decided to zone to R-1, and he would like to give the neighborhood and the developer a chance to speak.

Mr. Wayne Cropp stated that he was a resident of the Big Ridge community and had a very keen interest in this, as did the rest of the community: that he would like to say thanks to a number of people: that this had been discussed in a logical and orderly way to meet the concerns of the community. He went on to say that they did not oppose development of this area but did oppose to high density; that 700 residents signed a petition in opposition to the application as it was first submitted; that he appreciated the opportunity to talk to Mr. McMann and Mr. Erwin and that these discussions had led to a number of understandings. The developer was now ready to request R-1 Zoning only and the Townhouse Zone had been dropped; there will be only one access road into and out of the property. He stated that he would also like to express appreciation to Councilman Page for facilitating meetings between the developer and the community. He also acknowledged that Mr. Erwin had made significant improvements and that he appreciated this; that there had been significant upgrades, and he had listened to the concerns of the neighborhood and was now seeking R-1 Zoning, and the neighborhood did not oppose this as R-1 and again expressed appreciation for the work of the Planning Staff, Councilman Page, and the developer.

Councilman Hakeem stated that maybe he was confusing himself but there was a difference in what was read and what was being said.

Mr. Pace explained that we would have to do a substitution for next week for R-1 only for second reading.

Attorney Nelson stated that we could either cut and paste tonight's Ordinance or make the correction over the weekend before next week's meeting; that it could be passed on first reading as is with the understanding that it will be amended next week.

On motion of Councilman Page, seconded by Councilman Littlefield, AN ORDINANCE TO AMEND ORDINANCE NO. 6958, AS AMENDED, KNOWN AS THE ZONING ORDINANCE, SO AS TO REZONE TRACTS OF LAND LOCATED AT 4500 AND 4501 GANN STORE ROAD, MORE PARTICULARLY DESCRIBED HEREIN, FROM R-1 RESIDENTIAL ZONE AND C-2 CONVENIENCE COMMERCIAL ZONE TO R-1 RESIDENTIAL ZONE AND R-T/Z RESIDENTIAL TOWNHOUSE/ZERO LOT LINE ZONE, SUBJECT TO CERTAIN CONDITIONS

passed first reading, with the understanding that this will be amended to R-1 Zone only before second reading next week.

Mr. Erwin and Mr. McMann were present in the interest of this case. Mr. McMann spoke and began with acknowledging what had taken place. He stated that they did work through a process and continued to meet with community members; that their interest was to be a good neighbor, and they had shown that they could be a good neighbor and had reached a point where they were willing to request of the Council that they be rezoned to R-1 in the entirety and the TownHouse Zone will no longer be part of this development.

Attorney Nelson suggested that Traffic Engineering review this so that when it is zoned to R-1, it will be final.

Mr. Pace added that on this plat there are three lots to the north and five lots facing Gann Store Road; that we need to make sure that this will be a safe access to Gann Store Road.

Councilman Franklin stated that he had one question. He wanted to know whether the lot lines were 0 ft. Mr. McMann explained that they were standard—10 ft. on each side and 25 ft. on the front and rear.

Councilman Page stated that he believed that some of the lots do face Gann Store Rd. and wanted the Traffic Engineer to approve this—that some do face Gann Store Rd.

Mr. McMann stated that they were willing to acquiesce to the Traffic Engineer.

Councilman Page stated that the neighborhood and developer worked hard, and he really appreciated this; that this was tough, and this will be a good development, and he thanked them for the compromise and also thanked the neighborhood for their energy. He went on to ask that the Planning Staff make sure that the Land Use Plan is reflected in this and that it is developed in a manner that will coincide with the present development that is there.

At this point Vice Chairman Robinson went over the procedure that is followed in initial zoning cases and the light system that we have for timing speakers.

REZONING St. ELMO NEIGH.

2005-017 (City of Chattanooga)

Pursuant to notice of public hearing, this case came forward to be heard. Mr. Jerry Pace of RPA explained that this is a Zoning Adjustment Study, and we have already had a presentation on this, but there is Staff present for a further presentation if necessary.

Councilman Taylor took this opportunity to thank RPA for all of their hard work and the neighborhood for working along with them. He noted that the President of the Neighborhood Association was present tonight.

Councilman Littlefield asked if there was anyone present who was for or against this; if not, he was prepared to vote.

2005-020 (Charles L. Lockwood and Frankie L. Lockwood)

Pursuant to notice of public hearing, this case came on to be heard. Mr. Jerry Pace, Operations Director of RPA, made the presentation. He stated that this was located in East Chattanooga along Harrison Pike and is currently zoned R-3; that there is some R-5 in the area; that the last time we had a rezoning for a mobile home was in 1990, but it is appropriate in this area; there is some single-family around the area and other mobile homes to the west in an R-1 area. He sated that they were recommending only rezoning the front 300 ft. perpendicular from Harrison Pike and R-5 for the remaining portion along Boyce Street. There will be no driveway access to Harrison Pike.

Pursuant to notice of public hearing, this case came on to be heard. Mr. Jerry Pace, Operations Director for RPA, made the presentation. He stated that this was in the East Brainerd area in the Hamilton Mall neighborhood; that there are conditions on this for berms and landscaping, and they are asking that these conditions be revised. He stated that they reviewed the site, and it meets with their approval. Development on the front has already begun and all access is from Ziegler and Gunbarrel Rd. to the property, and it does come with a recommendation from the Planning Commission and Planning Staff.

Councilman Page indicated that he was a little uncomfortable with this because it is in Councilman Benson's area, and he is not present. Councilman Littlefield assured Councilman Page that if he had any problem with this, he would be calling in.

This comes with a recommendation from the Planning Commission and Staff. Public Works has asked that there be one condition—that they would like for the Traffic Engineer to review this property.

He first congratulated those on the Council who were elected last Tuesday and congratulated Councilman Taylor on his leaving for future endeavors. He stated, however, that he was still in a run-off and was still "running" but there was an adequate number of Councilmen left to do business. Councilman Taylor responded "Thank you Mayor Littlefield!"

ALBANIAN DELEGATION

At this point Vice Chairman Robinson acknowledged that some of the members from Albania were now present and extended a formal welcome to them and expressed how much we had enjoyed their stay here. She asked if any of the members would like to come to the podium to make any comments. There being none, she extended a very hearty welcome to them.

EMINENT DOMAIN

Councilman Hakeem asked Attorney Nelson if in this case we had dotted all our "i's" and crossed all our "t's". Attorney Nelson responded that he assumed we had; that this is part of the Spot Blight program, and they had been involved for months.

Adm. Kenardo Curry stated that in some cases, years; that all four of the Resolutions on tonight's agenda cause blight on the community and have had many repeated warnings to do the right thing, and in many cases rehab could be accomplished, and they could be placed back on the tax rolls; that they had worked with the Attorney and had received no collaboration with the property owners. He went on to say that this began in early 2003, and this is the second phase of a lengthy process; that he had had one connection with a property owner, and he had delayed action, and he had been asked to go ahead and re-hab.

Councilman Taylor verified that we had been working with them since 2003 and there had been no action.

Mr. Curry stated that they had refused to respond to certified letters and judicial orders; that the taxes are paid and current; that if the taxes had been in arrears, they would have already been dealt with.

Councilman Taylor verified that what they needed to do to prevent this was to step forward with a plan of action. Mr. Curry stated that this would have to be within 30-90 days.

The time will be from 8:00 a.m. to 7:00 p.m. at the Election Commission and from 10:00 a.m. to 6:00 p.m. at the North Gate Community Center and the Brainerd Recreation Center. It will start on March 23rd and go to April 7th—Monday through Saturday with the exception of March 25th when the sites will be closed for Good Friday.
