Chairman Robinson called the meeting of the Chattanooga Council to order with Councilman Bennett, Benson, Franklin, Hakeem, Pierce, Rico and Rutherford present; Councilman Page was absent due to the death of his mother. City Attorney Randall Nelson, Management Analyst Randy Burns and Council Clerk Carol O'Neal, CMC, were also present.

Mr. Pace, Director of Development Services with the Regional Planning Agency (RPA), stated the request for this tract of land started prior to the new Council coming onboard and is land located in the Southside area that CNE is developing into residential uses. He stated the matter has been tabled three times and there are now questions about the capital budget. He stated it is his belief Councilman Pierce questioned the city's participation in building a road across this property, which would be a public street. He stated he did not know if the matter should be tabled again or not as there is concern about the road and financing of the property.

**Councilman Benson** stated he does not feel ready to move forward with this until there has been adequate talk and questions answered by CNE officials. He stated the original cost was \$600,000 to the city, then heard it shot up to one million and is now hearing there is uncertainty that it is in the Mayor's capital budget.
