City Council Building Chattanooga, Tennessee November 22, 2005 6:00 P.M.

Chairman Robinson called the meeting of the Chattanooga City Council to order with Councilmen Benson, Franklin, Hakeem, Page, Pierce, Rico and Rutherford present. Councilwoman Bennett was absent due to prior personal commitment. City Attorney Randall Nelson; Management Analyst Randy Burns; and Shirley Crownover, Assistant Clerk to the Council, were also present.

PLEDGE OF ALLEGIANCE/ INVOCATION

Councilman Jack Benson led the Pledge of Allegiance, followed by invocation given by Reverend Ben Nelson of St. Paul's Episcopal Church.

MINUTE APPROVAL

On motion of Councilman Page, seconded by Councilman Pierce, the minutes of the previous meeting were approved as published and signed in open meeting.

SPECIAL PRESENTATION: WALNUT STREET BRIDGE

Mayor Ron Littlefield joined Chairman Robinson at the podium to receive a commendation from the American Society of Civil Engineers. Mr. Don Warrington, with the American Society of Civil Engineers and Ms. Karen Headlee, President of the American Society of Civil Engineers, presented to the City the award by the nominating committee of the state section of the American Society of Civil Engineers, designating the Walnut Street Bridge as a Tennessee Historical Landmark. The purpose of this award is to note the historic achievement of this profession. The Bridge was constructed in 1891 and is the oldest crossing of the Tennessee River. It is one mile long and an engineering marvel. Mr. Warrington explained that it is a living monument, due to the efforts of Mayor Littlefield, who had it restored and redeveloped in 1993. He noted that it is the centerpiece of our downtown re-development. He thanked Mayor Littlefield and apologized to Councilman Benson for "disturbing his sleep" in getting all of the paperwork done. He stated that it was their pleasure to designate the Walnut Street Bridge as a Tennessee Historical Engineering Landmark.

WALNUT STREET BRIDGE (CONT'D)

Chairman Robinson accepted this great honor on behalf of the City. She noted that many walk the Walnut Street Bridge again and again and say this is their favorite walking area. She added that she had been privileged to work with the committee to save the Bridge, and it was wonderful to see what it had become.

Mayor Littlefield added his thanks, too, stating that he would have to find an appropriate place to display this honor in the newly renovated City Hall; that it is remarkable that this is the oldest river span. He mentioned that he had a black and white picture on his wall in the Mayor's Office that is a large panoramic view of the City taken in 1906, and the Walnut Street Bridge was the only bridge; that 99 years later things are quite different, and it is a prominent downtown structure. He thanked Mr. Warrington and Ms. Headlee for the great recognition, noting that it would be a great addition to our treasury.

Councilman Benson also thanked Mr. Warrington for doing this work, explaining that the reference to disturbing his sleep was because he had already gone to bed when Mr. Warrington, who his is neighbor, had called him. He stated that Mr. Warrington had done his work and this was a long overdue recognition of a great asset to Chattanooga; that Ms. Headlee had helped him, and he appreciated all the work.

Chairman Robinson added that this was the longest pedestrian span in the world, and she also thanked them very much.

LEONARD WELLINGTON

Chairman Robinson called on Adm. Beverly Johnson, who stated that Mr. Wellington had resigned as a member of the Human Rights-Human Relations Commission and was no stranger to anyone; that he was a well-known and well-respected community volunteer and was leaving after many years of service. She stated that Councilman Rico would make the presentation to Mr. Wellington.

Councilman Rico stated that it gave him pride to present this plaque to Mr. Wellington; that he, himself, had been a past chairman of the Human Rights-Human Relations Commission and at this point he read the wording on the plaque that emphasized how Mr. Wellington had worked for the betterment of human relations in Chattanooga.

Mr. Wellington thanked Mayor Littlefield and the Council for the plaque, asking God's blessings on all. He noted that he saw so much history here and commented on the nice City Council assembly room.

<u>LEONARD WELLINGTON</u> (CONT'D)

Mayor Littlefield stated that Mr. Wellington was getting on in years and wanted to take it easier; that we would keep him around, like the Walnut Street Bridge; that he had been his friend for a long time and met with the "Saturday Luncheon Club" at Wally's and was always a "settling" influence.

passed second and final reading and was signed in open meeting.

REZONING

2005-168 (Institute of Healing & Health—Wildwood Lifestyle Center)

It was noted that more time is needed on this issue.

On motion of Councilman Hakeem, seconded by Councilman Rico,

AN ORDINANCE TO AMEND ORDINANCE NO. 6958, AS AMENDED, KNOWN AS THE ZONING ORDINANCE, SO AS TO REZONE A PORTION OF A TRACT OF LAND LOCATED AT 4580 CHAMBERS ROAD, MORE PARTICULARLY DESCRIBED HEREIN, FROM R-1 RESIDENTIAL ZONE TO R-3 RESIDENTIAL ZONE, SUBJECT TO A CONDITION was deferred until January 10, 2006.

AMEND CITY CODE SCHOOL ZONE SPEED LIMITS

Councilman Hakeem stated that this was discussed at length in the Public Works Committee meeting, and it was requested that additional research be done and no timeline was set.

Councilwoman Rutherford suggested four weeks.

On motion of Councilman Hakeem, seconded by Councilwoman Rutherford,

AN ORDINANCE TO AMEND CHATTANOOGA CITY CODE, PART II, CHAPTER 24, ARTICLE VIII, SECTION 24-242(1), RELATIVE TO SPEED LIMITS IN SCHOOL ZONES was deferred until January 10, 2006.

AMEND CITY CODE REL. TO BOARDS AND COMMISSIONS

Councilman Benson explained that the Legal and Legislative Committee recommended approval of this Ordinance but since that time it was decided that some fine tuning is needed, and it is not ready for approval.

On motion of Councilman Benson, seconded by Councilman Rico,

AN ORDINANCE TO AMEND CHATTANOOGA CITY CODE, PART II, CHAPTER 2, BY ADDING A NEW ARTICLE X111 RELATIVE TO BOARDS AND COMMISSIONS was deferred for one week.

CLOSE & ABANDON

2005-185 (Trust for Public Land c/o Rick R. Wood)

Councilman Hakeem stated that this was discussed in the Public Works Committee and comes with a recommendation for approval. At this point he expressed appreciation to the Trust for Public Land and Mr. Davenport, noting that this has been in the works for at least two years and is finally coming to fruition. Chairman Robinson also agreed that Mr. Davenport works timelessly on such issues.

CLOSE & ABANDON (CONT'D)

On motion of Councilman Hakeem, seconded by Councilman Franklin,

Councilman Benson indicated that he thought they needed more time than that and Councilwoman Rutherford suggested February 7, 2006.
