Chattanooga Council Building May 23, 2006 6:00 P.M.

Chairman Pierce called the meeting of the Chattanooga City Council to other with Councilmen Bennett, Benson, Franklin, Gaines, Rico, Robinson, and Rutherford present. Councilman Page was absent due to prior commitment. City Attorney Randall Nelson; Management Analyst Randy Burns; and Shirley Crownover, Assistant Clerk to the Council, were also present.

INVOCATION/ PLEDGE OF ALLEGIANCE

Councilwoman Bennett led the Pledge of Allegiance, followed by the invocation.

MINUTE APPROVAL

On motion of Councilwoman Robinson, seconded by Councilman Rico, the minutes of the previous meeting were approved as published and signed in open meeting.

SPECIAL PRESENTATION:
JIM MELIA-WOUNDED
WARRIOR PROJECT

Chairman Pierce noted that there was a Special Presentation and called on Councilwoman Robinson.

Councilwoman Robinson stated that it was a great pleasure to present a Certificate of Appreciation to Mr. Jim Melia on behalf of the City of Chattanooga. She proceeded to read the Certificate, which was signed by all members of the Council and at this time she asked Mr. Melia to tell us a little bit about this project, noting that it was a compelling story that had been told earlier in committee.

JIM MELIA (CONT'D)

Mr. Melia thanked the Council for this proclamation, stating that he was hesitant to accept this honor in his name as it really represented over 15,000 wounded men and women. He explained that the Wounded Warrior Project began in a basement in Roanoke, Virginia with his older brother who had been wounded in the war; that he was cognizant of the many people who had been wounded in Afghanistan and Iraq and began handing out backpacks to them containing useful items; that Walter Reed Hospital heard about this and needed more of the backpacks; that his brother had quit his job and devoted himself fulltime to this effort. He noted that over \$3 million dollars had been raised and mentioned recent legislation signed by the President entitled "The Wounded War Bill". He stated that the sacrifices he himself had made paled in comparison to the sacrifice of all these wounded men and women. He went on to mention that veterans would be riding into Chattanooga; that they had departed on May 8th and ridden across country from California. They will be arriving in Chattanooga on May 31st, and the event will be hosted at Coolidge Park, and Mr. Melia stated that he would like to have all of the Council present to meet these "real" heroes—that they had asked for nothing in return, and we owed them everything. He thanked the Council for their kind words, stating that he was looking forward to seeing them on May 31st.

Chairman Pierce further expressed his gratitude to Mr. Melia and acknowledged what he had done with a very worthy cause.
