CITY COUNCIL BUILDING CHATTANOOGA, TENNESSEE JUNE 27, 2006

Chairman Pierce called the meeting of the Chattanooga City Council to order with Councilpersons Bennett, Benson, Franklin, Gaines, Rico, Robinson and Rutherford present. Councilman Page was absent due to prior commitment. City Attorney Randall Nelson; Management Analyst Randy Burns; and Shirley Crownover, Assistant Council Clerk, were also present.

PLEDGE OF ALLEGIANCE/INVOCATION

The Pledge of Allegiance was led by Councilwoman Rutherford, followed by invocation given by Attorney Randall Nelson.

MINUTE APPROVAL

On motion of Councilwoman Rutherford, seconded by Councilman Benson, the minutes of the June 13th Council meeting were approved as published and signed in open meeting. On motion of Councilman Franklin, seconded by Councilwoman Rutherford, the minutes of June 20th were approved as published and signed in open meeting.

SPECIAL PRESENTATION: MARSHALL FELLOWSHIP

Councilman Rico wished everyone a good afternoon, stating that he had the honor of introducing the European Marshall Memorial Fellowship. He asked each person to introduce themselves to the Council and then turned the meeting over to **Jerome Geudj** of France.

Mr. Geudj addressed the Council, apologizing for his "ugly" French accent. He stated that he was very impressed to meet the Council; that they had spent four days in Chattanooga and confessed that most of them did not know anything about Chattanooga before their arrival; however they would go back to Europe and tell that they saw a City with passionate energy. He stated that they had met people from different origins on their trip, who had all told them about the future of their cities; that they had been told that Chattanooga had overcome many things in the past.

MARSHALL FELLOWSHIP (CONT'D)

Mr. Geudj went on to say that they met important people in Washington who explained to them that people in the United States were of two cultures: "To Be" and "To Do"—that Chattanooga was a "To Do" City. He went on to say that they were very impressed with what they had seen and could go back to Europe with some practical ideas. He mentioned the involvement of citizens in the City, which he stated was very exciting and how they had appreciated the quality of life in Chattanooga. He stated that they had had a wonderful and interesting time here and that they would never forget Chattanooga, adding "thanks a lot".

SPECIAL PRESENTATION: ACT "SPOKESCRITTERS"

Mayor Littlefield stated that he had had a wonderful time meeting with the Marshall Fellowship; however he expressed some difficulty in telling them what he had to do next on his agenda—introducing a dog and a cat! He noted that a number of people had been working diligently on our new animal shelter; that plans and designs had been long in the making, and we had been presented with regular reports. He mentioned that Barbi Wilson had headed up the campaign, which had attracted many investors, most notably being Mr. McKamey, for whom the new shelter is named.

He brought attention to the two appropriate "Spokescritters" for this undertaking, explaining that there had been competition for these two animals. The dog and cat chosen had the appropriate background, as they were both "pound" critters; they also had the right personality and attractive qualities and the right kind of composure for the job. He introduced "Harry" the "Spokesdog" and "Mack" the "Mascat", stating that they were both quite friendly and knew no strangers. He also noted that Harry loved the French people, pointing out that "Mack", a short-haired Tabby, was not quite so comfortable. He reiterated that both came from the pound and noted that both were beautiful animals, and their owners had allowed us to use them. He turned the presentation over to Mrs. Wilson.

"SPOKESCRITTERS" (CONT'D)

Mrs. Wilson stated that she would be brief—that "Harry" and "Mack" were true representatives of what ACT was all about; that ACT had been created in August of 2004 and many thought we would never make it this far; that on July 20th there would be a groundbreaking for the new center, which is an exciting and historic thing for Chattanooga. She stated that she hoped all of the Council would support them and talk this up. Mayor Littlefield was holding "Mack" and Mrs. Wilson expressed hope that the cat would not bite him!

AMEND CITY CODE ALCOHOLIC BEVERAGES

Councilman Benson stated that Ordinances (a) and (b) both come with a recommendation for approval from the Legal and Legislative Committee and that Ordinance (a) would require substitution. Councilwoman Rutherford asked what the substitution was for and was told by Attorney Nelson that it involved the effective date. Councilman Benson added that also a person under the age of 21 had to be accompanied by an adult. Councilwoman Rutherford asked if this was just an adult or a parent. Councilman Benson responded that it could be either a parent or guardian.

On motion of Councilwoman Rutherford, seconded by Councilman Franklin,

AN ORDINANCE TO AMEND CHATTANOOGA CITY CODE, PART II, CHAPTER 5, SECTIONS 5-48, 5-75, AND 5-82, RELATIVE TO BEER AND ALCOHOLIC BEVERAGES

was substituted. On motion of Councilwoman Rutherford, seconded by Councilman Franklin, the Ordinance passed second and final reading and was signed in open meeting.

AMEND CITY CODE: PARKING

Attorney Nelson explained that he was asked to change the effective date on this Ordinance to make it effective immediately on passage; that he had dictated this change to Ms. Crownover.

On motion of Councilwoman Rutherford, seconded by Councilwoman Robinson,

AN ORDINANCE TO AMEND CHATTANOOGA CITY CODE, PART II, CHAPTER 24, SECTION 24-305, RELATIVE TO PARKING was substituted. On motion of Councilman Rico, seconded by Councilwoman Rutherford, the Ordinance passed second and final reading and was signed in open meeting.

2006-090 (Mary Sue Foskey)

On motion of Councilman Rico, seconded by Councilman Franklin, AN ORDINANCE TO AMEND ORDINANCE NO. 6958, AS AMENDED, KNOWN AS THE ZONING ORDINANCE, SO AS TO REZONE TRACTS OF LAND LOCATED AT 2819 AND 2821 WALKER ROAD, MORE PARTICULARLY DESCRIBED HEREIN, FROM R-2 RESIDENTIAL ZONE TO O-1 OFFICE ZONE, SUBJECT TO CERTAIN CONDITIONS

passed second and final reading and was signed in open meeting.

AMEND CITY CODE CHATT. POLICE DEPT.

On motion of Councilman Rico, seconded by Councilwoman Rutherford, AN ORDINANCE TO AMEND CHATTANOOGA CITY CODE, PART II, CHAPTER 16, ARTICLE III, BY REPEALING SECTIONS 16-44, 16-45, 16-47, AND 16-48, RELATIVE TO THE CHATTANOOGA POLICE DEPARTMENT passed first reading.

BUDGET ORDINANCE FY 2006-2007

Councilwoman Bennett stated that this was discussed in the Budget and Finance Committee and comes with a recommendation for approval.

On motion of Councilman Rico, seconded by Councilwoman Robinson, AN ORDINANCE, HEREINAFTER ALSO KNOWN AS "THE FISCAL YEAR 2006-2007 BUDGET ORDINANCE". TO PROVIDE REVENUE FOR THE FISCAL YEAR BEGINNING JULY AND **ENDING** JUNE 30. 2007, AND APPROPRIATING SAME TO THE PAYMENT OF EXPENSES OF THE MUNICIPAL GOVERNMENT; FIXING THE RATE OF TAXATION ON ALL TAXABLE PROPERTY IN THE CITY, AND THE TIME TAXES AND PRIVILEGES ARE DUE, HOW THEY SHALL BE PAID. WHEN THEY SHALL BECOME DELINOUENT: PROVIDING **FOR** INTEREST AND PENALTY DELINQUENT TAXES AND PRIVILEGES AND TO AMEND CITY CODE CHAPTER 18, SEC. 18-123(g)

passed first reading.
