CITY COUNCIL BUILDING CHATTANOOGA, TENN. April 22, 2008

Chairman Bennett called the meeting of the Chattanooga City Council to order with Councilmen Benson, Berz, Franklin, Gaines, Page, Rico and Robinson present. Councilman Pierce was absent due to prior commitment. City Attorney Randall Nelson, Management Analyst Randy Burns, and Shirley Crownover, Assistant Clerk to the Council, were also present.

PLEDGE OF ALLEGIANCE/ INVOCATION

The Pledge of Allegiance was led by Councilman Rico, followed by invocation.

MINUTE APPROVAL

On motion of Councilman Rico, seconded by Councilwoman Robinson, the minutes of the previous meeting were approved as published and signed in open meeting.

SPECIAL PRESENTATION: STUDENTS OF DR. JEAN HILL

Dr. Jean Howard-Hill thanked the Council for the opportunity for her students to speak tonight. She stated that they were trying to take the lessons learned from text books and lectures and put them into practical application; that they had diligently researched for facts on different issues in order to draw conclusions. She stated that there would be five presenters tonight and each would try to take about two minutes; that this was an opportunity to see that we have young people who are doing good things.

The first student to speak was **Matt Kreitzer**, who stated that his Study was in three areas concerning Accessibility and Accommodations for the Disabled in Hamilton County. He mentioned education as being the foundation for model citizens and the 14th amendment guaranteed equal protection under the law for all citizens. In the way of recommendation, Mr. Kreitzer stated that discrimination isn't a de jure, or by the law, problem; rather it is a de facto problem, which lies in the actual execution of policy. He stated that it is important to place public policy into perspective and have outside input from someone in the affected community.

SPECIAL PRESENTATION (CONT'D)

Shane Uselton was the next student to speak. His report was on Chattanooga City Taxes. He stated that over the past five years, the City of Chattanooga has received annual increases in revenues received from property and local sales tax due to steady growth in the business and industrial sectors. The City of Chattanooga has also grown in property acquisition with record-breaking home sales in 2005 and 2006. Residential and Industrial property assessments for Chattanooga have increased by 27.56%. In Fiscal Year 2008, Chattanooga is expected to see a 4.9% increase in revenue provided by the countywide sales tax. In addition the City will see a 3% increase of revenue from redistribution of 5.5 to 5.75% of the state sales tax. He stated that his recommendation would be that the property and sales tax remain constant at their current He mentioned two programs—The Property Tax Freeze for Chattanooga residents 65 years of age and older and The Streamline Sales Tax Project Program. He stated that his recommendation would be to consider the younger citizens. Also the long term effects of the Property Tax Freeze will place a bigger burden on taxpayers under 65 years of age if the tax rate is ever increased.

L.C. Fagin, Jr. was the next speaker. His topic was Employment Practices in the City of Chattanooga. He stated that he "lucked out" and found out that discussions were already in place, and the City was in the process of revising a total Compensation Package. He mentioned the issue with pensions, noting that Chattanooga has a General Pension Plan and a Fire and Police Pension Plan. He noted the shortfall in the Fire and Police Pension Plan of between \$55 million versus \$92 million. He stated that this issue should be resolved, and there was no point in belaboring it.

Shane Uselton also reported on Public Education, stating that the numbers were not good. Our Public Education System ranks very low in the State of Tennessee and with Georgia nearby, parents tend to think that their System is better and people are moving into Georgia because of this. He stated that we need to make education better and more appealing, starting with a marketing program with scholastics being the first priority and less emphasis on sports; that when we fail in education, we are failing our future.

Peter Guild was the last student to speak. His topic was Crime and Public Safety in the City of Chattanooga. He noted that there were many concerns and citizens want more officers on the street but want to pay less money; that the City is reluctant to fund the pension; that there is a cost for everything if the City wants to meet the needs of the public. He stated that citizens do feel safer than they did a decade ago and hopefully this trend will continue. He mentioned that we do have better technology, such as the new cameras, but on the other hand, police officers are underpaid and over scrutinized. He went on to talk about the recent shootings, noting that promoters and club owners should be held responsible. He mentioned the renovations at the 911 Call Center, stating that we had a 20% drop in calls and were among the best in the He stated that he had interviewed Mayor Littlefield and Councilman Rico, who were positive about the crime wave; that we need more resources in the department so that citizens can experience heightened safety and less crime; that if we don't pay our officers, we will see an upscale of crime.

Councilman Franklin commended Dr. Hill and her class for a good presentation, stating that if we need any research done, we will know where to go; that they had talked about the key elements that we are dealing with and again commended Dr. Hill.

Councilman Benson stated that this was discussed in the Legal and Legislative Committee earlier with a recommendation for approval.

Councilwoman Robinson explained that the Agreement with Friends of the Festival is for management and keeping track of events—that they are the "eyes" and "feet" on the ground, and we contract for these services to assure the proper level of safety and sanitation. The next Resolution merely assures that they have use of the Park for the Riverbend Festival.

COMMITTEES

Chairman Bennett asked that Councilpersons please let her know which committees they were interested in chairing; that there would be some new assignments.

Councilman Rico reminded everyone of the **Public Works Committee** meeting scheduled for Tuesday, April 29th at 3:00 p.m.

SGT. JULIA DEAN

Sgt. Julia Dean, President of the International Brotherhood of Police Officers, addressed the Council wearing a horse's yoke with a carrot dangling on a stick around her neck. She stated that she was bringing the actual item because this analogy works well with the way city employees feel—that the symbolism of the carrot is their pay. She stated that in October of 2007, the Pay Study was completed and since then they had been led by a carrot; that they became all excited, but October came and then Christmas, and they could not buy gifts without working extra

jobs—that October came and went; they were then told that by the end of the year something would happen—that numerous rumors were circulated then that it had to be done by the end of January; that December came and went and then came the time that they had to pay off their credit cards that they had used at Christmas. She stated they were told definitely in January, and they did not know the amount, but January came and went. Then came February, and they talked with the City Administration; that she and three others spoke with Mayor Littlefield on the 26th of February, and he told them to give him "a couple of days". Sgt. Dean stated that she being a sarcastic person, asked him if "Sir, you mean Biblical Days?" She went on to say that then the rumor mill spoke of March 14th—that March 14th is gone now, and it is April! Sgt. Dean stated that they had been patient and had had to hold off their creditors. She went on to say that they were taking this very seriously; that it was humiliating to her to have to carry the yoke and carrot around.

Chairman Bennett asked Dan Johnson or Donna Kelley if they would like to respond. Neither volunteered and Councilman Page asked that Donna Kelley give a response.

Ms. Kelley responded that the point was well taken and that she shared some of the same feelings; that after October 31st, a lot of work had to be done to get us to the point we are at today. She stated that we had accomplished some of the goals; that there would be meetings for all employees starting tomorrow throughout the City; that these would be informational meetings to find out individual status.

Chairman Bennett stated that it seemed like things were ready to go. Ms. Kelley stated that it would also be posted on the website.

Councilwoman Berz thanked Sgt. Dean for coming tonight, stating that she welcomed her when she showed up; that she, herself, was a marcher and respected her right to keep coming to these meetings; that she should not feel humiliated. She thanked her for being here and "sticking to her guns".

SGT. BRENDA HAFLEY

Sgt. Brenda Hafley spoke next, stating that it was only the Tuesday night people on the protesting lines tonight—that this was the Tuesday night crowd; that they would be at every function in this City until they got something in writing; that they were going to keep going until they got something in writing on their pay for the Fiscal Year 2009—that they had already dealt with Fiscal Year 2008. She stated that they were putting everyone on notice—that they would be at the Aquarium, Riverbend and everyone in the City would know what is going on. She stated that they did not want to do anything behind anyone's back but were just letting the Council know where they stood and what they would do.

Councilwoman Berz stated that she hoped they understood that the Council was not offended for them sticking up for their rights; that Ms. Kelley and everyone were working hard and that no one was offended; that there was freedom of association, and the Council was behind them in this.
