#### **HEARING: LAWRENCE GOODINE**

City Attorney Nelson stated the attorney has changed for the Lawrence Goodine hearing and has asked that the date be postponed to July 28. He stated that the panel now consists of Councilmen Rico, Berz and Franklin, with Councilwoman Robinson as alternate.

### **HEARING: LAWRENCE GOODINE (Continued)**

Councilman Benson stated this is an unusual situation as the case has already been heard by the judicial court and is now before to us to reinstate. He stated he would not want to serve on the panel unless the entire Council served; that three members on this case are somewhat of a convoluted process and he would not want to be a party to it.

City Attorney Nelson expressed that he anticipates it will be a very lengthy hearing and it is better for Council members to check their calendars twice before requiring anyone to attend.

Councilman Pierce expressed agreement with Councilman Benson and stated the entire Council or at least five members should serve; that there might be one or two alternates.

Councilwoman Berz stated that she has a conflict with the date and would be in mediation training and indicated that she does not know anything about the case but can not serve on that day.

The hearing for Lawrence Goodine was rescheduled for Monday, July 28 beginning at 9 a.m. with Councilmen Bennett, Benson, Pierce, Rico and Robinson serving on the panel.

#### **HEARING: SHAUN STANDIFER**

City Attorney Nelson stated a request for hearing has been received from Shaun Standifer regarding his termination as Senior Firefighter from the Chattanooga Fire Department.

Councilman Pierce asked if the Council could know what Mr. Standifer was charged with to cause his termination.

At this point City Attorney Nelson read the letter from Mr. Standifer: "... I wish to appeal the decision made to terminate my employment with the Chattanooga Fire Department. The decision was based on the results of a urine drug test performed on or about April 11, 2008. The test reportedly indicated the presence of amphetamines. As I stated in the Disciplinary Hearing, I do not use illegal drugs and did not use any illegal drugs prior to taking the test. I will present witnesses and evidence at the appeal hearing to justify reinstatement as Senior Firefighter with the Chattanooga Fire Department ..."

### **HEARING: SHAUN STANDIFER (Continued)**

A hearing for Mr. Standifer was scheduled for Monday, July 7 beginning a 9 a.m. with Councilmen Page, Berz and Pierce serving as the panel; Councilwoman Gaines volunteered as alternate.

#### **TEMPORARY USE**

Chairman Bennett stated last week during her absence a Resolution was adopted for temporary use on Aetna Mountain Road. She stated that she has received several calls even thought the matter has been approved and wants to make sure all property owners are contacted and understand exactly what the temporary use entails. She stated there is an old history with the road being blocked off and property owners not having access and wanted to be sure that does not happen in this case. She stated she would continue to make sure it is open and transparent and that the community is very involved.

#### COMMITTEES

Councilman Rico scheduled a meeting of the **Public Works Committee for Tuesday**, **May 27 beginning at 3 p.m**.

#### KHALID HASHMI

**Khalid Hashmi** of 202 West 38<sup>th</sup> Street was present and indicated that he and his organization, the Chattanooga Community Council, have been working on civil rights issues.

At this point Councilman Pierce interrupted Mr. Hashmi and asked his residential address.

Mr. Hashmi responded 244 Bookout Road, Ringgold, Georgia, 30736 is his home address. He stated the Chattanooga Community Council asked him to distribute information regarding a Civil Rights Clinic scheduled for May 27 at 7 p.m. at the Southside Recreation Center. He read from a flier that was later distributed to Council members that referenced stopping violence, crimes and drugs, restoring civil and human rights and a disparity study that was not approved. He stated if Council members have any ideas on what he can tell citizens in this regard to please tell him. (A copy of Mr. Hashmi's flier is filed with minute material of this date.)
