City Council Building Chattanooga, Tennessee July 15, 2008 6:00 p.m.

Chairman Bennett called the meeting of the Chattanooga Council to order with Councilmen Benson, Berz, Gaines, Page, Pierce, Rico, Robinson and Shockley present. City Attorney Randall Nelson, Management Analyst Randy Burns and Council Clerk Carol O'Neal were also present.

PLEDGE OF ALLEGIANCE/INVOCATION

Following the Pledge of Allegiance, Councilman Benson gave invocation.

MINUTE APPROVAL

On motion of Councilman Rico, seconded by Councilwoman Gaines, the minutes of the previous meeting were approved as published and signed in open meeting.

SPECIAL PRESENTATION: WORLD CHANGERS

Mayor Littlefield stated that he has been at Hunter (Museum) today and the wonderful announcement of the great event (Volkswagen plant); that all know it is a life changing event for the future of Chattanooga! He stated he is just as fortunate as one of his favorite programs is before the Council tonight, the World Changers. He stated several years ago he was made aware of the program and the good work they do. He stated that he does not easily tear up, however, he has gone around and visited some of the sights where young people who work with World Changers as volunteers pay to participate every summer to help those that are underprivileged; that some have serious problems with their homes -- rotted floors, bathrooms, roofs leaking -- people with no opportunity or resources to fix these and put them back in order. He stated he has seen some really remarkable transformations in the housing of some of our citizens. At this point he asked Vanessa Jackson of Neighborhood Services to come forward to introduce tonight's special guests.

<u>SPECIAL PRESENTATION: WORLD CHANGERS</u> (Continued)

Vanessa Jackson stated that the World Changers are not strangers to our city; that they have become our friends and are considered as change agents for the work they have done in the neighborhoods in Chattanooga and throughout She stated the project is funded in part with CDBG dollars administered by Neighborhood Services and awarded to Front Porch Alliance, the Department's partner in this venture. She stated Brainerd Baptist plays a strong part in providing lodging for the weeks and the Church does a phenomenal job providing lunches, snacks, fruit, candy, and popsicles whatever is needed for respite to deal with the grueling task of repair work. She stated of all the initiatives Neighborhood Services participates in, this is one of the most meaningful as it provides tangible support and assistance to some citizens who need it the most. She stated 47 projects will be done within a one week period and at the end of this year's project, they will have exceeded 200; that in fact, they will have performed work on 207 houses by the end of this year through the World Changers project. She stated each Council person will receive a letter listing projects taking place in their respective districts. At this point she introduced the persons present: Bill Kagay of the North American Mission Board of the Southern Baptist Convention; Josh Kagay, Bill Kagay's grandson and a volunteer and Rick and Pam Rector, this year's Construction Coordinators with the project who are "jewels" to work with, all of whom are from Chattanooga. She also recognized Matt Burkett, 2008 World Changers Team Leader, and Beth Trussell, Executive Director of the Front Porch Alliance.

Mayor Littlefield read the proclamation proclaiming July 16-28, 2008 as "World Changers Home Repair Weeks" which has been spread upon the minutes:

WHEREAS: Since 1990, World Changers, a dedicated Christian supported organization, has sought to provide Christian youth and adults with opportunities to meet the physical needs of others through practical learning, servanthood, and personal commitment to missions, and

WHEREAS: World Changers work diligently to provide physical and spiritual revitalization of the home and heart by performing home repairs to deserving senior citizens and qualifying homeowners, and

WHEREAS: Through their generosity and positive public service record, World Changers has and continues to impact the housing stock throughout the City of Chattanooga by free construction labor to those less fortunate, and

WHEREAS: This year, in continued partnership with the Department of Neighborhood Services, Community Development and Front Porch Alliance, World Changers will celebrate their sixth year of creative construction projects in our community which have demonstrated their respective goal to "change the world" of the homeowners of our city, and

Now Therefore, I, Ron Littlefield, Mayor of the City of Chattanooga, do hereby proclaim July 12-26, 2008 as

World Changers Home Repair Weeks

Be it further resolved the residents of Chattanooga join with me in congratulating and recognizing the members of this organization for their efforts to encourage and guide our youth by teaching them to serve those less fortunate. We wish them much success in all of their future endeavors.

LIFT CONDITIONS

2008-111: Dale M. Smith

Councilman Page asked for an update from last week's discussion from Public Works or Planning as opposed to the applicant.

Greg Haynes, Director of Development Services with the Regional Planning Agency (RPA), stated that he would report what he has found since last week. He stated the request is to lift conditions that have to do with utilities in this right-of-way. He stated a letter has been received from the Gas Company indicating it is okay with them to lift conditions; a letter from EPB says it is okay, as well, however, AT&T's letter indicates they prefer that the condition not be lifted as they still have an easement. He stated in reference to the Water Company, the applicant is present and can speak to the letter.

LIFT CONDITIONS (Continued)

Mr. Haynes stated that is all he can report and noted that Planning, Staff and Public Works recommend approval to lift conditions and keep a condition that says it has to be "approved by the city engineer and all public utilities"; that way the conditions currently can only be lifted as they relate to the Gas Company, EPB and the Water Company. He stated any further action would have to be approved from the utilities that remain which would be the telephone company and he guessed the applicant would have to work something out. He stated that the City Attorney could do a better job in explaining than he.

City Attorney Nelson stated that he has not seen any of the documents, yet, and would really like to look at them before the Council approves this.

Councilman Page made the motion to defer the matter one week and addressed the City Attorney by stating when alleys are abandoned or closed the person who is going to be the owner of the alley is still subject to any easements by any utilities; that that is way he thought it happens. Councilman Rico seconded the motion.

Councilman Rico asked if it is being said there is no way to lift conditions even if we wanted to.

Councilman Page clarified that he is asking for the City Attorney's opinion.

Chairman Bennett stated that she remembers from last week there was a question about enough time and asked the applicant if one week is enough time as the City Attorney is not comfortable.

Dale Smith, applicant, responded that it would not be enough time with the Water Company; that a couple weeks would be okay with the telephone company and noted that he talked to them and it seems it might be long and drawn out. He asked for at least 30 days.

At this point Councilman Page amended his motion to defer 30 days and stated that he would like to know from the City Attorney what the Council's jurisdiction and authority is in cases like this,

City Attorney Nelson responded this may make a difference.

Councilwoman Gaines asked if it is possible to pass this ordinance subject to the condition all utilities approve. City Attorney Nelson responded "no".

TEMPORARY USE

Councilman Benson stated approval is recommended but he can not personally support this as he believes in separation of church and state.

TEMPORARY USE (Continued)

Councilman Benson stated that history has proven freedom of religion requires we maintain a clean separation between church and state and any erosion of this line endangers both church and state, which is the reason for his position. He stated he has been to this church and attended a wedding there a few years ago and knows it is back up in the neighborhood and a fine church, but we turned down Second Presbyterian on Pine Street a few months ago when he realized what we were doing. He stated he is still concerned about what this will do and what it will open up to all of the churches throughout this city of using public property, government property. He stated it is his thought it is an intrusion into our separation clause of the First Amendment and will vote against this.

Councilman Page stated that he is voting for it; that any 501(c)3 non-profit can do this. He stated that it is his thought the Council would be wrong to exclude churches from that arena, which is the reason he is voting for it.

On motion of Councilman Shockley, seconded by Councilman Pierce,

He stated that he asked for an inspector to contact him and whenever the inspector came he was never contacted. He stated some guys came out and blew out the drain and the pipe busted. He stated that he talked with the person and was told it was his (Diamond's) responsibility. He stated this is not on his property; it is in the street and provides access to his garage. He stated that he has a blueprint of the property and photos and can not get anyone to come out and talk to him.

Chairman Bennett stated Adm. Leach is present and can speak with him after the meeting.
