CITY COUNCIL BUILDING CHATTANOOGA, TENNESSEE December 2, 2008

Chairman Bennett called the meeting of the Chattanooga City Council to order with Councilmen Benson, Berz, Gaines, Gilbert, Rico, Page, Pierce and Robinson present. City Attorney Randall Nelson; Management Analyst Randy Burns; and Shirley Crownover, Assistant Clerk to the Council, were also present.

PLEDGE OF ALLEGIANCE/INVOCATION

The Pledge of Allegiance was led by Councilwoman Gaines, followed by invocation given by Councilman Rico.

MINUTE APPROVAL

On motion of Councilwoman Robinson, seconded by Councilwoman Gaines, the minutes of the previous meeting were approved as published and signed in open meeting.

CARTA APPROP.

On of Councilwoman Berz, seconded by Councilwoman Robinson, AN ORDINANCE APPROPRIATING FROM THE CAPITAL PROJECTS FUND TO THE CHATTANOOGA AREA REGIONAL TRANSIT AUTHORITY (CARTA) AN AMOUNT NOT TO EXCEED NINE HUNDRED EIGHTY-FOUR THOUSAND FIVE HUNDRED NINETY-TWO DOLLARS (\$984,592.00) TO BE USED FOR THE NORTH SHORE GARAGE AND CAPITAL NEEDS OF CARTA AND **AUTHORIZING** THE ADMINISTRATOR OF THE DEPARTMENT OF FINANCE TO ENTER INTO AN AGREEMENT WITH CARTA TO REIMBURSE THE CITY AN AMOUNT NOT TO EXCEED FOUR HUNDRED SEVENTY-NINE THOUSAND TWO HUNDRED EIGHTY-EIGHT DOLLARS (\$479,288.00) OVER A TERM OF TEN (10) YEARS AT AN INTEREST RATE OF FOUR PERCENT (4%)

passed second and final reading and was signed in open meeting.

AMEND CITY CODE RELATIVE TO SIGNS

Councilman Benson stated that this was discussed in Legal and Legislative Committee today. Chairman Bennett clarified that there were two different Ordinances and it was the other one that was discussed today.

On motion of Councilwoman Gaines, seconded by Councilman Rico, AN ORDINANCE TO AMEND CHATTANOOGA CITY CODE, PART II, CHAPTER 3, SECTIONS 3-6, 3-94, 3-101, 3-102, 3-131, AND 3-132, RELATIVE TO SIGNS

passed second and final reading and was signed in open meeting.

AMEND ORD. 11704 PLYMOUTH LANE

On motion of Councilman Rico, seconded by Councilwoman Robinson, AN ORDINANCE AMENDING AND MODIFYING ORDINANCE NO. 11704 (CASE NO. MR-2005-075) WHICH IS AN ORDINANCE CLOSING AND ABANDONING A PORTION OF THE 7500 BLOCK OF PLYMOUTH LANE, MORE PARTICULARLY DESCRIBED HEREIN AND AS SHOWN ON THE MAP ATTACHED HERETO AND MADE A PART HEREOF BY REFERENCE, SUBJECT TO CERTAIN CONDITIONS

was substituted. On motion of Councilman Page, seconded by Councilman Robinson, the Ordinance passed second and final reading and was signed in open meeting.

AMEND ORD. 11705 HEWITT LANE

Councilman Benson stated that he thought these changes needed to be made clear—that there had been changes between the first reading and the second reading tonight, and he asked that someone explain these changes.

HEWITT LANE (CONT'D)

Adm. Leach stated that he was the one appointed to do this and that he would go ahead and read the proposed Ordinance.

Councilman Page stated that everyone did need to know what they were doing, but he did not see any reason to review the whole project; that just some of the language in the Ordinance had been changed, and he did not see the purpose in going through the whole thing again.

Adm. Leach felt that he needed to read Section 2 of the Ordinance: BE IT FURTHER ORDAINED, That this closure and abandonment shall be subject to the City retaining a sewer easement for the full width and length of this right-of-way until such time as Shady Oaks Subdivision is replatted to provide for new alignment of the sewer line and utilities previously constructed along the right-of-way of Hewitt Lane. At such time, the City Engineer and Utility Owners shall approve any relocations or modifications of this existing sewer line and utilities within the dedicated right-of-way on the subdivision plat.

Adm. Leach explained that this provides for the sewer line that already exists; that the City will maintain the existing sewer line in place and a portion into Hewitt Lane; that we will retain the sewer line in Hewitt Lane until Lot 12 wants to relocate.

Mrs. Jacquelyn Smith questioned whether Adm. Leach was saying that they would retain a 20 ft. or 50 ft. easement.

Adm. Leach explained that the way this Ordinance reads, the sewer line is for the full length—only the part that is in the right-of-way; that the other portion through to Lot 12 would be 50 ft. He stated that Mrs. Smith's concern was with the next Ordinance coming up.

On motion of Councilwoman Gaines, seconded by Councilman Page, AN ORDINANCE AMENDING AND MODIFYING ORDINANCE NO. 11705 (CASE NO. MR-2005-076) WHICH CLOSED AND ABANDONED A PORTION OF THE DEDICATED RIGHT-OF-WAY WITHIN THE 7500 BLOCK OF HEWITT LANE, MORE PARTICULARLY DESCRIBED HEREIN AND AS SHOWN ON THE ATTACHED MAP HERETO AND MADE A PART HEREOF BY REFERENCE, SUBJECT TO CERTAIN CONDITIONS

was substituted. On motion of Councilwoman Gaines, seconded by Councilman Gilbert the Ordinance passed second and final reading and was signed in open meeting.

CLOSE AND ABANDON

MR-2008-137 (Jacquelyn C. Smith)

Adm. Leach explained that additional language was placed in this Ordinance and proceeded to read Section 2.

Section 2 reads as follows: "BE IT FURTHER ORDAINED that this closure and abandonment shall be subject to the City retaining the existing easements for the existing sanitary sewer on lot 12, and that the City, AT&T, and Tennessee-American Water Company retain an easement in the center between lots 11 and 12 for the full length and 20 feet width of this platted right-of-way for future sewer relocation and/or easements for the utilities for existing and future use."

Adm. Leach stated that at this point, the City would retain the easement that would be essentially the new property line.

On motion of Councilman Pierce, seconded by Councilman Page,

CITY ATTORNEY

This meeting will be held at noon on Tuesday, December 9th.

At this point. Chairman Bennett noted that each Councilperson had received a letter from our favorite City Attorney stating that he will be leaving at the end of the year. She stated that we would be sorry to lose him.

Attorney Nelson thanked Chairman Bennett and stated that he meant every word that he had written in his letter to each of the Councilmembers; that he shared a lot of memories with the Council.

Chairman Bennett stated that the Council would have a lot more to say; that we are just now processing this and everyone is shocked.

COMMITTEES

Councilman Rico scheduled a **Public Works Committee meeting to follow the Agenda Session on Tuesday, December 9**th. The meeting will cover Public Works matters for the current and following week and also a discussion regarding the Highland Park Zoning Study.

Councilman Page announced that there would be an **Economic Development Committee meeting to immediately follow Public Works committee on Tuesday, December 9th.** A Chattem PILOT will be discussed.

Chairman Bennett announced that there would be a Lookout Valley Christmas Parade on **Saturday, December 13**th; that Volkswagen has offered to provide a car for Councilmembers and she urged that each Councilperson let Mrs. O'Neal know if they could attend. The lineup starts at 11:00 a.m. and the parade will be at noon.

Councilman Gilbert noted that **Resolutions (h) and (k)** on next week's agenda were discussed in the Parks and Recreation Committee meeting today.

Councilwoman Gaines scheduled a **Safety Committee meeting** for **Tuesday, December 16th to immediately follow the Legal and Legislative Committee meeting.** She stated that she would provide more information later.

Councilman Benson announced that there would be a **District 4** Neighborhood Meeting at **7:00 P.M. on Thursday, December 4**th **at the Concord Baptist Church.** He stated that he would appreciate the Staff being there as he was expecting from 200 to 300 people to be present.

Councilman Pierce stated that his Christmas Parade would be on Main Street on **Saturday**, **December 6**th; that this would be a 24-hour event and that he and Councilman Rico shared this area and were debating who would be the Grand Marshall; that last year they rode in a BMW Convertible. He stated that he would appreciate everyone coming down that day.
