On motion of Councilman Murphy, seconded by Councilman Gilbert,

A RESOLUTION TO ESTABLISH A SPECIAL FUND FOR THE POLICE DEPARTMENT AND FIRE DEPARTMENT TAKE HOME CARS; AUTHORIZING THE POLICE CHIEF AND FIRE CHIEF TO ACCEPT DONATIONS TO SAID FUND; EXPRESSING THE INTENT OF THE CITY COUNCIL TO AMEND THE BUDGET ORDINANCE TO ALLOCATE TO THIS FUND ANY UNSPENT EXPENSE FUNDS OF THE COUNCIL TO DATE AND

SPECIAL FUND FOR POLICE DEPARTMENT AND FIRE DEPARTMENT TAKE HOME CARS (Cont'd.)

THREE QUARTERS (3/4) OF UNSPENT TRAVEL FUNDS; AND FURTHER EXPRESSING THE INTENT OF THE COUNCIL TO AMEND THE BUDGET ORDINANCE TO DELETE THE CHARGES FOR TAKE HOME CARS WHEN MORE THAN FIVE HUNDRED THOUSAND DOLLARS (\$500,000.00) IN TOTAL SAVINGS FROM EITHER NET REVENUE COLLECTED OR EXPENSES FOREGONE IS OBTAINED.

Lengthy discussion held as to how funds would be allocated to specific areas or officers if designated to special fund and that would be responsibility of Chief Dodd to determine how funds would be allocated. Attorney McMahan advised that police officers cannot solicit funds and that in cases of general solicitation, there would be no earmarks. Councilwoman Scott questioned whether funds allocated in budget could be pulled to cover the costs of these take home cars since majority agreed that donations were not good idea.

Councilwoman Ladd stated that she was against resolution and was afraid that we were opening Pandora's Box and that she would hate to be in Chief Dodd's job as to how he would distribute funds. Stated that both Chief Dodd and Former Chief Cooper thought all officers should be treated equally across the board and that this could split the Department. Councilwoman Ladd stated that she did not believe this was a wise decision and that she was against it.

Councilman Gilbert stated that one suggestion would be that City police officers could keep cars and those living outside city limits could be charged from the City limits line at a rate of \$.30 per mile to their homes.

Councilman Benson agreed with Councilwoman Ladd. Stated that this was dysfunctional and no way to do business. Stated that those that live outside the city limits do not pay city taxes and the citizens of the City of Chattanooga were footing the bill for them to take cars outside city limits. Stated that it was not right for citizens to pay for city cars to go outside city limits.

Councilman Murphy stated savings will get to over half million dollars. Three fourths of department park cars. Will get over one third savings on parked cars alone and shorten period of time that officers are driving cars. He was afraid that this increases the time of emergency response and stated that this City Council was stingy. Doesn't think it's a fool's errand. Having officers respond to calls when they are not on duty.

SPECIAL FUND FOR POLICE DEPARTMENT AND FIRE DEPARTMENT TAKE HOME CARS (Cont'd.)

Councilman Murphy stated he is very concerned knowing police or fire as he does and gave example of: Arson investigator does not have car when fire occurs at 2:00 a.m. Sooner or later they will have wreck and discussed whether they are on duty or not whether we are liable or not.

Councilwoman Berz stated this band-aid is not rational. She is very much for officers having their cars. Suggested we handle this in professional fashion rather than piece good fashion. Does not bother her if officers live in city or county. Look at budget to see if they can take their cars home. \$20,000 to get lot ready. Nothing lost there. One thing she's seeing is if we can find savings, we will immediately put cars back on road. Feels very strongly to not demean officers and fire personnel. Thinks we are a better city than that. Suggests we immediately go to look for savings in budget to start taking their cars home.

Councilwoman Scott agreed that funding through donations does not set well. Citizens are in favor of officers in city taking cars home free of charge. Also, people willing to subsidize cars for county residents. People that want them parked are for money coming from donations. \$135,000 in police travel budget. Cannot move money out of travel budget?

Dan Johnson stated travel budget is for training purposes. \$300,000 total in every other department in City. Item VII(m) (management agreement with Trust for Public Land) is already in budget.

Daisy Madison discussed contract funding on VII(m).

Larry Zehnder stated the contract on VII(m) is for a twelve month contract. Stated he would have to hire 2 to 3 employees to get through what Trust for Public Land does under this contract. Thinks it would be destructive to cancel contract.

Councilwoman Robinson stated that the prevailing opinion is that we want police cars out there. Budget issue cannot be fixed tonight. Wrong to open up City of Chattanooga budget to donations. Amending city budget has been turned down time and time again. Things can be fixed but does not know for next 5 or 6 months and try to make it through end of this year. People feel better knowing cars are out there.

Councilman Benson stated that 2/3's of police drive cars into County.

Councilman Gilbert suggested putting police cars off until we can agree on funding. County people drive to end of city limits and pay to their houses rather than from Amnicola Highway.

Councilwoman Berz again stated that she favors them having their cars. This is not how to do it. Wants to take a look at budget. Budget can be amended without tearing whole budget apart. Might be able to do several things. Cannot make those decisions tonight. Not sure it is a good idea to keep travel money. Put on agenda after meeting with Daisy Madison to come up with alternative plan. That should be in budget full time with their cars. Will vote against it as is.

Councilman Benson moved to substitute 7(d) for now and Police Chief to continue use of cars. Bring back recommendation to those that live in city. Have to stop city officers from taking cars into county. Wants city policemen to drive for free. Get County to pay for those that live in county until Mayor can come back with plan.

Sharon Peeker, Wisteria Drive, Hixson, TN. Spoke on police cars within city limits. Thought police officers are not paid enough to live in the City. Police should be allowed to take cars home. Without Police Department and Fire Department, the city could not exist. Could exist without parks, probably would not like it, but could exist. Stated there was waste by every department and should make every department more accountable.

Demetrus Coonrod, 1120 Greenwood Road. Lives in District 5 and lost her fiancé to shooting last February. Feels if more officers take police cars home, it might deter someone from committing crime.
