CITY COUNCIL BUILDING AUGUST 9, 2011 6:00 P.M.

Chairman Ladd called the meeting of the Chattanooga City Council to order with Councilmen Benson, Berz, Gilbert, McGary, Murphy, Rico, Robinson and Scott present. City Attorney Michael McMahan, Management Analyst Randy Burns, and Kathy Camp, were also present.

PLEDGE OF ALLEGIANCE/INVOCATION

The Pledge of Allegiance was led by Councilman Gilbert, followed by invocation.

MINUTE APPROVAL

On motion of Councilman Rico, seconded by Councilwoman Berz, the minutes of the previous meeting were approved as published and signed in open meeting.

SPECIAL PRESENTATION RECOGNITION OF YOUTH BY PARKS AND RECREATION

The City of Chattanooga Parks and Recreation and the City of Chattanooga City Council recognized dozen of local athletes that have competed in the numerous sporting events throughout the spring and summer. Those recognized at City Council competed in various events in baseball and track and field, held locally in Chattanooga to as far away as Atlanta, Georgia, Phoenix, Arizona, and Hershey, Pennsylvania. Larry Zehnder recognized Greta Hayes and she presented the winners to the Chattanooga City Council. Councilman Andrae McGary congratulated the youth and the Parks and Recreation Department for their hard work, which was echoed by all City Council members. Following the presentation, Larry Zehnder presented newspaper articles to the council members and gave a report of the revenues that were generated in Chattanooga because of the City's investments into the softball fields and the economic values of these youth programs and the continued generation of revenues from these investments. ADJUSTING BOUNDARIES/ CHATTANOOGA CITY LIMITS

On motion of Councilman McGary, seconded by Councilman Gilbert, AN ORDINANCE ADJUSTING BOUNDARIES OF THE CITY CHATTANOOGA AND THE CITY OF COLLEGEDALE PURSUANT TO T.C.A. § 6-51-302 TO PROVIDE THAT THE ROAD RIGHT-OF-WAY OF APISON PIKE BEGINNING ON THE SOUTH EASTERN CORNER OF THE RIGHT-OF-WAY OF APPISON PIKE AT THE INTERSECTION OF PATTENTOWN ROAD AND APISON PIKE AND FOLLOWING THE SOUTHERN BOUNDARY OF THE APISON PIKE RIGHT-OF-WAY UNTIL IT MEETS THE CURRENT CITY LIMITS OF THE CITY OF COLLEGEDALE AT THE EASTERN SIDE OF THE RIGHT-OF-WAY OF AN UNNAMED ACCESS ROAD WHICH IS THE CURRENT ENTRANCE TO THE SUMMIT OF SOFTBALL PARK AND THE SUMMIT LANDFILL; THENCE NORTHBOUND FOLLOWING THE CITY LIMITS OF THE CITY OF COLLEGEDEALE TO THE NORTHERN RIGHT-OF-WAY OF APISON PIKE: THENCE WESTWARD BACK TO THE CURRENT CITY LIMITS OF THE CITY OF CHATTANOOGA AT THE INTERSECTION OF APISON PIKE AND PATTENTOWN ROAD; AND THENCE SOUTH TO THE POINT OF BEGINNING SHALL BECOME PART OF THE CORPORATE LIMITS OF THE CITY OF COLLEGEDALE BY MUTUAL AGREEMENT AS SHOWN ON THE ATTACHED MAP.

LIBRARIES

On motion of Councilman McGary to approve, seconded by Councilman Gilbert, AN ORDINANCE TO REPEAL CHATTANOOGA CITY CODE, PART II, CHAPTER 22, LIBRARIES, IN ITS ENTIRETY, AND TO REPLACE IT WITH A NEW CHAPTER 22.

was discussed by the City Council. Concerns were expressed about references in the ordinance to "Free" and "Independent." Councilman Murphy stated that he thought there were issues with the Ordinance. City Attorney Michael McMahan suggested that the matter be deferred for one week. On motion of Councilman McGary, seconded by Councilman Rico, the matter was deferred for one week.

On motion of Councilwoman Berz, seconded by Councilman Gilbert,

REZONING

On motion of Councilwoman Berz, seconded by Councilman McGary, AN ORDINANCE TO AMEND CHATTANOOGA CITY CODE, PART II, CHAPTER 38, ZONING ORDINANCE, SO AS TO REZONE PROPERTY LOCATED AT 9300 AND 9400 BLOCK OF LEE HIGHWAY, MORE PARTICULARLY DESCRIBED HEREIN, FROM C-2 CONVENIENCE COMMERCIAL ZONE TO UGC URBAN GENERAL COMMERCIAL ZONE, SUBJECT TO CERTAIN CONDITIONS.

REZONING

On motion of Councilman Benson to deny, seconded by Councilman Murphy, AN ORDINANCE OT AMEND CHATTANOOGA CITY CODE, PART II, CHAPTER 38, ZONING ORDINANCE, SO AS TO LIFT AND AMEND CONDITIONS ON ORDINANCE NOS. 11290 AND 11372 ON PROPERTIES LOCATED IN PART AT 706 ASHLAND TERRACE, BEING MORE PARTICULARLY DESCRIBED HEREIN.

was discussed. Councilman Benson advised that applicant had advised that he would withdraw his request. Applicant was not present at City Council meeting. Councilwoman Robinson suggested that a request be made to the Regional

Planning Agency to conduct a meeting with landowners and take a look at the Land Use Plan of 2003 and 2008 for that area. Greg Haynes advised that it had been referred to City Council. Councilwoman Robinson moved to withdraw, seconded by Deborah Scott and the motion passed.

REZONING

passed first reading.

REZONING

On motion of Councilman Rico, seconded by Councilman McGary, AN ORDINANCE TO AMEND CHATTANOOGA CITY CODE, PART II, CHAPTER 38, ZONING ORDINANCE, SO AS TO REZONE PROPERTY LOCATED AT 329 STRINGER STREET, MORE PARTICULARLY DESCRIBED HEREIN, FROM R-1 RESIDENTIAL ZONE AND C-2 CONVENIENCE COMMERCIAL ZONE TO R-4 SPECIAL ZONE, SUBJECT TO CERTAIN CONDITIONS.

Deborah Scott wanted information regarding this rezoning. Property owner, Jeff Bruce, was present and advised that they were seeking the rezoning to provide more space to the Bill Shores Art Studio and a one condominium unit above the art studio. Deborah Scott expressed concern regarding commercial traffic and the need to keep people out of these areas after normal business hours. Councilwoman Scott expressed a need for a chain or barrier of some kind to keep people out after normal business hours. Mr. Bruce stated that he would prefer a security system with cameras rather than a chain or barrier. City Attorney Michael McMahan suggested the following condition be added to the Ordinance, "ENTRANCE OFF OF STRINGER STREET TO BE CONTROLLED BY PHYSICAL BARRIERS OR SECURITY AFTER BUSINESS HOURS UNLESS THE CONDOMINIUM IS OCCUPIED." After adding this condition, the Ordinance, as amended, was passed on first reading.

MARK 1 KITS

On motion of Councilman McGary, seconded by Councilwoman Gilbert, A RESOLUTION AUTHORIZING THE FIRE CHIEF TO ORDER THREE THOUSAND ONE HUNDRED EIGHTY (3,180) MARK 1 KITS FROM THE HAMILTON COUNTY HEALTH DEPARTMENT TO REPLACE EXISTING MARK 1 KITS CARRIED ON ALL FRONT-LINE FIRE APPARATUS, FOR A TOTAL PROJECT COST IN THE AMOUNT OF ONE HUNDRED THOUSAND TWENTY-THREE THOUSAND SEVEN HUNDRED SIXTY-SIX DOLLARS (\$123,766.00).

was adopted.

SPECIAL EXCEPTION PERMIT

On motion of Councilman Rico to deny, seconded by Councilman Benson A RESOLUTION APPROVING A SPECIAL EXCEPTIONS PERMIT FOR A HOME FOR THE AGED AND HANDICAPPED ON PROPERTY LOCATED AT 614 MOOREMONT TERRACE.

Councilman McGary addressed the applicant and advised him that this council denied special exception permits in general and that it was nothing to single out the applicant. Following a brief discussion, said request was denied.
