She stated there was a huge sign at The Howard School today and a huge response when Dr. Gandhi walked in. She stated Dr. Gandhi's speech was amazing, as well as the students. She acknowledged the principal Paul Smith as amazing leader and noted tomorrow they would be at The Baylor School and the two schools will continue to work together.

Admin. Crutchfield stated when she picked up Dr. Gandhi from the airport after flying from Tokyo for 38 hours he told her he was tired but happy to be here in Chattanooga. **Dr. Arun Gandhi** stated this is a great day of honor for him and does not know that he really deserves it as his grandfather did all the hard work and he is the one who gets all the honors for it! He stated he would do his best to live up to it and his philosophy and expressed thanks for the honor, especially becoming partners in the Season for Nonviolence, a season he started in 1998 to commemorate his grandfather's 50th Memorial Anniversary. He stated he was sitting in his home in Memphis, Tennessee wondering how to do this meaningfully and it occurred the same year as Dr. Martin Luther King's 30th Memorial Anniversary and thought that it was a wonderful thing and decided to link the two memorial anniversaries and call that 64 day period a Season for Nonviolence.

# SPECIAL PRESENTATION: DR. ARUN GANDHI – "UNBROKEN: A SEASON FOR NONVIOLENCE" (CONTINUED)

Dr. Gandhi stated he thought it would be a one year affair, celebrating the 50 and 30th anniversaries and it would be all over; that the first function was at the United Nations and was amazed nearly 5,000 people turned out for it and at the end of the function all of them unanimously got up and said this is not going to end; that the season is going to be an ongoing thing. He stated he is amazed more today that we have more than 200 communities in the United States and a few around the world partnering in the Season for Nonviolence and doing whatever little they can to take us a few steps closer to the dream Dr. King and his grandfather shared. He stated the dream is of creating communities of peace and harmony everywhere in the world and he is really happy Chattanooga has joined and we are going to do wonderful things. He stated he and Ms. Crutchfield have been talking about great things for Chattanooga and expressed hope the dreams will materialize; that one of the things they want to do here is establish a Gandhi Global Center for Nonviolence and she is going to be the "backbone" of that center and he will help make it possible. He stated he hopes the community will welcome the idea and partner in making this dream come true; that maybe Chattanooga can become the first city not only in the nation but in the world to promote peace, nonviolence and harmony. He stated these big dreams are there and invited everyone to participate in making the dream come true. He stated he will treasure this honor for the rest of his life.

Admin. Crutchfield stated being the "backbone" of this vision is more like doing the grunt work; that she will be coming to the Council and the community to try to build the vision and build a reality and expressed her thought we could have a center for nonviolence here.

Chairman Ladd stated this is a wonderful idea and one she would like to see come to fruition. She thanked Dr. Gandhi for the time he has taken with our young people and leaders and talking the message we need to continue this dialogue everyday here in Chattanooga. At this time she recognized Commissioner Tim Boyd and asked him to say a few words as he was a contributor to this visit of quite a sum of money to enable this to come to total fruition in having Dr. Gandhi here this week.

**Commissioner Tim Boyd** stated it has been an honor to have Dr. Gandhi visit Chattanooga and present his idea of a global center for nonviolence here in Chattanooga and to be a part of something like that is quite historical.

# SPECIAL PRESENTATION: DR. ARUN GANDHI – "UNBROKEN: A SEASON FOR NONVIOLENCE" (CONTINUED)

Commissioner Boyd stated in a telephone conversation with Missy last week they talked about the t-shirt that Councilman Gilbert is wearing tonight and how they were going to put "Season of Nonviolence" on it and mentioned to her what season means is a temporary part of your life and it ends. He stated our seasons of the year start and stop and he mentioned to Missy this is a season we do not want to end -- the season that never ends. He expressed appreciation for her taking note of that and placing it on the t-shirt for our community to recognize this will not be and cannot be a season that ends. He referenced some of the naysayers about studying the Gang Task Force and recognized Boyd Patterson and Fred Houser for their work as they have a vision for this city of nonviolence and we must recognize what they are battling is not a temporary fight. He stated people that fight in the gutters and on the streets and hurt our people are working 24/7 and we as elected officials have a moral obligation to our community to take note and determine how we can have a sustainable fight against the forces of evil in our community. He expressed hope his fellow County Commissioners will align with County Council members and work toward this goal because it is so important to our future. He stated he is happy to have Dr. Gandhi here and thrilled to be a part of it and glad to see it come to fruition. He concluded his comments by thanking Dr. Gandhi, Ms. Crutchfield and the Council.

City Attorney McMahan reported the intention to appeal to the Sixth Circuit Court of Appeals Judge Collier's decision in former Officer Hoback's case.

### TIME CHANGE: COUNCIL MEETING, OCTOBER 2, 2012 T 5:00 P.M.

Councilman Rico stated October 2 is "National Night Out" and asked what the Council plans to do, whether a short agenda, no agenda or no meeting; that all neighborhood associations will participate and he has six-or-seven to attend, himself. He stated it will be hard to have a meeting and try to make all of them as Council members are expected to attend.

Councilman Murphy asked if there is a way to get staff to bring things forward or things that can wait and have it as a fairly short, perhaps no content agenda.

Councilwoman Berz stated there is a way to do both – have a brief meeting and start earlier at 5 p.m. or as soon as committees are over, or as early as 4:30 p.m.

Chairman Ladd stated that sounds like a good combination and the departments can be asked to not bring too much for that week; that the City Attorney can watch to see what the agenda looks like and perhaps start earlier.

Councilman Rico asked if there is adequate time to advertise it.

City Attorney McMahan stated there is time to advertise; that the Council meeting can begin following Committees at 5 p.m. on October 2.

### COMMITTEES

Councilman Rico scheduled a meeting of the **Public Works Committee for Tuesday, September 25 i**mmediately following the Agenda Session.

Councilman Benson scheduled a meeting of the **Economic Development Committee for Tuesday, September 25** following Public Works.

### NEXT WEEK'S AGENDA: September 25, 2012

Chairman Ladd referred Council members to next week's agenda and inquired as to whether there were questions; being none, the meeting continued.

### MATLA GRISSON

Matla Grisson of 1322 Grove Street in College Hill Courts read from a prepared statement as the representative of the Westside community Association which has been spread upon the minutes. She stated last week members of her organization had a brief moment to speak to the Housing Committee regarding their Affordable Housing Ordinance. She expressed thanks for the Council giving them that brief moment to discuss their solutions to the city's housing crises, however, they felt given the urgency of the city's housing situation and the nature of their legislation, they would like an opportunity to speak to the Housing Committee at a great length of time to more fully educate the Council on the strength of inclusive zoning policies. She stated they feel inclusive zoning offers a real opportunity to provide low income Chattanoogans a home in their own city; that it is the kind of legislation they are proposing that has been successful all throughout cities and states in America. She stated they have secured the aid of Courtney Knapp, a Cornell Ph.D. candidate in Urban Design to help craft the research of the legislation; that they feel it deserves a longer hearing. She stated the Westside Community Association asks that the Council schedule a full public hearing on the Affordable Housing Ordinance within the next couple weeks and requested at least 45 minutes duration for the session.

Councilwoman Scott stated Ms. Grisson mentioned inclusive zoning had been done in other places for the request the Westside Initiative is wanting; that she asked last week for some contact for that and was sent one city but that city had enacted the ordinance, it had gone into effect but there was not anyone who has actually gone through and worked under that. She wondered if Ms. Grisson would be able to provide the council with a list of other places where that has successfully been done so the Council can make contact.

Ms. Grisson stated they have a lot of statistics and facts that they could make available.

### **MATLA GRISSON (Continued)**

Councilman McGary stated he drafted an e-mail and dispensed it to all Council members citing an article that comes from Wikipedia where 200 communities are listed that have some form of inclusive zoning permit; that they have some forms or combinations of both from an incentive standpoint and even a mandate. He stated there is some combination of the two; that not all communities have a mandate, some have incentives or a combination of the two. He stated he found in his research that one of the communities passed an inclusive zoning ordinance in 1974, so we are not talking about some that is a just a couple years old or even ten years old; that there are successful examples; that not everything works in every place as different communities have done different things and can resubmit the e-mail. He reported to the Council he had a conversation with Kim White on Monday in lieu of the conversation that was had concerning bringing in RiverCity and their PILOT program and reported there are conversations taking place as it is a subject that is very timely and has a lot of "moving pieces". He stated one of the outcomes of the conversation is there needs to be a wider conversation involving the Department of Neighborhood Services, CNE, Chattanooga Housing Authority, RiverCity - a large conversation where everybody is able to come together in a public meeting, which is something Mrs. White and he both firmly agreed would push forward. He stated whether this is a conversation that will be held in 30 days perhaps might not be as realistic but is certainly a worthwhile goal that will be pushed forward and enable everyone who has a vested interest in this subject to chime in and come with a solution that will benefit everyone. He stated he will keep the Council updated.

Chairman Ladd stated she also had a meeting with Kim White and expressed the same interest that we have all stakeholders involved in the discussion and dialogue so we can share everything we have to put on the table; that it is her thought we will be able to do something soon. She asked Ms. Grisson to leave her contact information in an effort to get in touch with her.

Councilwoman Scott addressed Councilman McGary and asked when he was looking through the cities that had made those changes were they primarily in permanent housing or limited to rental.

Councilman McGary stated they range all across the board as some communities have inclusive zoning that encompasses condominiums, apartments, any private development and there is a certain percentage of that private development as some are on a one percent or as much as 10 percent.

### **MATLA GRISSON (Continued)**

Councilman McGary stated with any new project there would be a certain project that would have to be allocated to middle and low income housing based on the Federal Poverty Index. He stated some communities offer incentives, density requirements that build up to so many units in an area and as an incentive to help them meet this mandate they are allowed to build more units than what the zoning would require so they can make up for what they would lose by having the other moderate-to-low income requirements. He stated there are different programs across the board but the basic idea is there; that a certain portion of any new development has to be allocated to moderate and low income housing.

### **GLORIA GRIFFITH**

Gloria Griffith of 1115 Grove Street also read from a prepared statement noting that she wanted to go on record and reminded the Council that in December, 2010 nearly two years ago, the people of the Westside marched from the Renaissance Presbyterian Church to Buehler Brothers store to urge the city and Chattanooga's business community to help them get someone to open a store to replace the Dollar General Store that left them without a neighborhood grocery and they did nothing. She stated this spring Mr. Sal Mohammed announced that he would be opening a store in the space that Dollar General occupied and after a licensed electrical contractor completed his work, it took six months for the city's inspectors to arrive on sight and approve the facility. She stated several people in the community have reported to her that city policemen have told Mr. Mohammed that the Westside is a very dangerous place and that he should not expect his business to thrive; that it has been reported to her by Westside residents that after a similar visit, the police left and within a few minutes four men, who said they were gang members from another area of the city, told Mr. Mohammed that he should not plan to be in business for any length of time. She stated they feel Mr. Mohammed is a person who actually really wants work within their community and has thought about moving there. She stated the city Fire Marshalls determined that an overhead sprinkler system was required before the store could open and the people on the Westside commented that Dollar General, which is owned by the multibillionaire Koch brother, was not required to install such sprinklers. She stated Mr. Mohammed has tried everything; that the Fire Marshalls have yet to inspect the place and approve it; that six Fire Marshalls came at one time and did not tell him they were coming, they just came.

### **GLORIA GRIFFITH (Continued)**

Councilman McGary stated he participated in the march two years ago to raise awareness of the food desert that exists in the Westside and is sensitive to their plight; that he is also aware there was some concern about the number of fire inspectors and other individuals that have been to the store as had been reported. He stated he knows there was an e-mail chain started wherein Chief Parker reported.

Chief Parker stated they scheduled the meetings with the owner and there were two occasions he did not appear and was notified both times to appear; that he actually sets up the time and date he wants them to come to them, they were there twice and he did not show up either time. He stated they did meet on the 14th and sent an e-mail after Rev. Griffith came up; that it was not confrontational but had questions about the fire inspectors. He stated there were five people there, two were the Fire Inspectors and three were representatives from the sprinkler company; that the building was already sprinklered and they had to move one over the cooling unit in the back with a sprinkler head in case the motor caught fire. He stated a strobe horn was installed; that the things the owner needs to do for the Fire Department is minor and needs to put up a couple exit signs; that the fire extinguishers have been installed and the electrical is completed and stated in a note he received prior to the meeting. He stated as far as he is concerned he has minor things but has not shown up and has stood them up twice on two occasions.

Councilman McGary asked for clarity from Chief Parker's perspective the city has done nothing to obstruct this particular project.

Chief Parker stated that is correct that no one from his office has been contacted to slow anything down; that the owner has not appeared for two of the meetings when it could have been done two meetings ago and the store could have been done as far as inspections, but the owner did not show up. He the owner of the building showed but not the person who wants to puts the building in there as he leases it.

Councilman McGary stated the owner never gave reason why he did not show up. Chief Parker stated to the best of his knowledge he has not shown up for anything.

Admin. Leach reported as part of the inspection process a person does have to request final inspections; that he checked with staff this morning and the electrical has all been finalized; that the applicant has not requested final plumbing or commercial alteration permits.

### **GLORIA GRIFFITH (Continued)**

Admin. Leach stated there are certain things we expect the applicant to do and one of them is to notify us when he needs the finals. He stated we have done that portion that we can do.

Councilman McGary asked from Mr. Leach's perspective his department has done nothing to obstruct this project going forward. Admin. Leach responded "no".

Councilman Murphy stated he wanted to make it clear, noting he does not want to speak for Chief Dunn and no one would disagree with him, that it is not the policy or position of the leadership of the Chattanooga Police Department to discourage an appropriate commercial enterprise in any part of this city, in fact he knows the Chief and Lieutenants that met with folks trying to work on revitalization on Glass Street in East Chattanooga and there has been absolutely no effort to discourage people from doing that or from opening businesses there. He stated he wanted to be very clear because he thinks there could have been a misconception left from Mrs. Griffith's remarks, asking if it is someone's allegation after police officers talked to the gentleman about the neighborhood that police officers threatened him or four people unidentified threatened him.

Mrs. Griffith stated the police officer made a threat and the four people told him he would not last; that after the police left they (the four) arrived and does not know why they arrived after him and they were not even from the neighborhood. She said they said they were a gang and they were in our area and told him not to open up the store and if he did he would not last and that was the statement. She stated the person there with him at the time overheard that.

Councilman Murphy stated he is trying to make sure as it got muddier there than not clear. Mrs. Griffith stated she did not mean for it to get muddy. She stated it sounded to her and the person who was there who witnessed it that the man was being threatened by the police and by the gangs, and that is all she is saying.

Councilman Murphy advised if he has been threatened by the police please have him report that to Internal Affairs, although he would be stunned if that is what happened.

Ms. Griffith told him to do that and whether Councilman Murphy is stunned or not that is what was said.

### **GLORIA GRIFFITH (Continued)**

Councilman Rico stated he is sure there is a language barrier as he has been by there and talked to the gentleman and is sure, because he is not from here, may have a little trouble understanding; that sometimes it is a cultural thing about not keeping appointments; that the gentleman seems nice but does not think he speaks English very well.
