CITY COUNCIL BUILDING CHATTANOOGA, TENNESSEE DECEMBER 4, 2012

Chairman Ladd called the meeting of the Chattanooga City Council to order with Councilmen Benson, Berz, Gilbert, McGary, Murphy, Rico, Robinson and Scott present. City Attorney Michael McMahan; Management Analyst Randy Burns; and Shirley Crownover, Assistant Clerk to the Council, were also present.

PLEDGE OF ALLEGIANCE/ INVOCATION

The Pledge of Allegiance was led by Councilman Gilbert, followed by invocation.

MINUTE APPROVAL

On motion of Councilwoman Robinson, seconded by Councilman Rico, the minutes of the previous meeting were approved as published and signed in open meeting.

PUBLIC HEARINGS/ANNEXATION

Attorney McMahan opened the Public Hearing, noting that Attorney Noblett would present a number of slides—that a written report of each Plan of Services had been provided to Councilmembers.

Attorney Noblett explained that pursuant to State Law, public hearings are required on newly annexed areas in order for everyone to learn about the services that will be provided in newly annexed areas. These annexations occurred in 2009 to be effective in December of 2010. He presented a map of the entire city including the newly annexed areas of 3A, 3C, 4B, 8A, 9A, 10A, and 10B. He noted a number of services to be provided by the City, including fire and police protection, refuse collection, planning and zoning, code enforcement and recreational facilities and programs. He explained that there was an issue with WWTA Sewer Service for these areas, which will have to be resolved by the Court.

Adm. Leach went over each area, including annexed areas of Lookout Valley and Cummings Highway; Lookout Mountain; Hixson Pike, Big Ridge Area; north of Ooltewah; narrow strip on I-75; and south side of Lee Highway. He mentioned the fire stations that would service each area, including the new Fire Station 3, Lookout Valley Fire Station, Hixson Utility District, proposal of another Fire Station on the west side of I-75, and Fire Station 7 at Enterprise South. He mentioned the number of garbage cans in the Hixson Pike-Big Ridge Area and the Ooltewah area and pending fire hydrants in Hixson Pike-Big Ridge Area and Ooltewah area. He also talked

about the number of service calls in the Hixson Pike-Big Ridge area and the Ooltewah area, south side Lee Highway. He mentioned the narrow strip on I-75 that is being annexed where only billboards exist that will be serviced by a new fire station north of this area off Hunter Rd.

Attorney McMahan asked if there were any questions from the audience; there being none, the Public Hearing came to a close.

CITY ATTORNEY'S REPORT

Attorney McMahan stated that our work with WWTA to resolve issues had been alluded to; that we were unable to resolve the issue and the Courts would have to issue a Declaratory Judgment—that we are requesting to place sewers only in annexed areas and WWTA wants sewers in the total growth area and are not willing to work with us on this. He stated that he was preparing a lawsuit and would file it.

CHRISTMAS EVE

Councilman Gilbert stated that we discussed Christmas Eve two weeks ago; that he would like to have it worked out that the Council Staff could have that day off. Mr. Burns stated that the Council Staff had already worked this out among themselves.

Councilwoman Berz inquired if the Council had the authority to do this? Attorney McMahan responded that the Council has the authority over their Staff; that he thought Administration had agreed that city employees could take personal leave that day. Councilwoman Berz wanted to know if this would be mandating that employees take a day of personal leave?

Councilman McGary asked Mr. Johnson if Administration had made a decision on this, asking for an update. Mr. Johnson responded that it would **not** be a mandatory holiday—that it would be a regular work day.

Councilman Gilbert stated that he would like for the Council's clerks to be off, unless there was one who wanted to stay.

Councilman Murphy stated that the Council employees could take personal leave—that this was at the discretion of the Council Chairman—that the phones might need to be covered that day—that if it were up to him, it would be fine for all the Staff to take off—that it was up to the Chairman to bless this.

Councilman Benson stated that the staff are full-time employees of the City of Chattanooga and should follow what the City of Chattanooga does.

Councilman Gilbert maintained that the Council Staff could take a vacation day if they so desired. Chairman Ladd stated that she thought the Council Staff could handle this amicably.

COMMITTEES

Councilwoman Scott noted that the Personnel, Performance and Audit Review Committee met today and that this would be reported on the City's website under Committee minutes sometime next week.

Councilwoman Robinson scheduled a meeting of the Housing Committee on Tuesday, December 18th to immediately follow the Public Works Committee for a report on the lead that had been found in some yards of peoples' homes. She also wanted to report on the great neighborhood of Jefferson Heights that had taken ownership of their community—that a lady had been assaulted in her front yard, and the Police had been able to arrest him because of the neighbors' quick response and coming to her assistance.

COMMITTEES (CONT'D)

Councilman Murphy reminded everyone of the Legal, legislative/Safety Committee scheduled for Tuesday, December 11th, to immediately follow the Agenda Session.

Councilman McGary asked Councilwoman Robinson, as Chairman of the Housing Committee, to get the "ball rolling" on an Affordable Housing Committee. She stated that she would take this under advisement.

Councilman Gilbert scheduled a Parks and Recreation Committee for Tuesday, December 11th to immediately follow the Legal and Legislative Committee to discuss fees.

Councilwoman Berz scheduled a **Budget Educational Session on Tuesday, December 11th at 2:00 P.M.** in the Council Conference Room for a United Way Report on Agencies.

NEXT WEEK'S AGENDA: DECEMBER 11TH, 2012

Chairman Ladd referred Council members to next week's agenda and inquired as to whether there were questions; being none, the meeting continued.

LEROY GRIFFITH

Leroy Griffith of 1115A Grove Street addressed the Council concerning a 43-page e-mail, which was an analysis of the 2003 Blueprint to educate concerning the homeless—10 years ago and was presented by the City of Chattanooga and the Homeless Coalition. It referred to implementing Inclusive Zoning and the development of affordable housing in percentage ratio to other types of housing. He stated he did not know who wrote this, but it was not factual. It also spoke of providing an incentive for developers and tax rates for affordable housing, which was not defined. He emphasized that Inclusive Zoning had not been done in these 10 years.

COURTNEY KNAPP

Courtney Knapp of Central Ave. next addressed the Council, commending them on trying to "hammer" out what affordable housing means. She urged a definition of moderate and low income, also urging that people at the low spectrum of income not be overlooked.

Councilman Gilbert asked for a discussion of what went on 10 years ago concerning downtown housing since he was not on the Council then.

Councilwoman Robinson stated that the Council talked a lot about the homeless issue and a lot has been done regarding this; that the blueprint is ten years old, and we are still following it.

Councilman Benson asked Ms. Knapp to define inclusionary, wanting to know if she meant housing or zoning? She responded "inclusionary housing" overall; that we need a housing market that responds to the whole diversity—working class, middle class, and upper class, as well. Councilman Benson mentioned that we were trying to get inclusionary zoning to reconcile with commercial, which was called a mixed-use zone; that he feared we were getting off of inclusionary zoning and just including housing. Ms. Knapp spoke to mixed-use development and affordable housing close to businesses and where people work. She agreed that inclusionary was a "fuzzy word"—that we need to take the whole range and "cobble" it together to meet all needs. He wanted to know if she was behind inclusionary housing downtown. She stated her emphasis was on housing, again stating that it was a "fuzzy" term.

<u>ADJOURNMENT</u>

Chairman Ladd adjourned the meeting of the Chattanooga City Council until Tuesday, December 11th at 6:00 P.M.
