

City Council Building Chattanooga, Tennessee COUNCIL MEETING MINUTES

September 24, 2013 6:00 PM

CALL TO ORDER

Chairman Yusuf Hakeem called the meeting to order with Vice Chairman Henderson and Councilpersons Carol Berz, Chris Anderson, Moses Freeman, Russell Gilbert, Larry Grohn, Jerry Mitchell and Ken Smith all present. City Attorney Wade Hinton, Management Analyst Randy Burns, Deputy Clerk Nicole Gwyn and Council Support Cindy Patrick were also present.

PLEDGE OF ALLEGIANCE

Councilman Anderson led the assembly in the Pledge of Allegiance. Dr. David Brown (Pastor Dave) offered a prayer for the assembly.

APPROVAL OF LAST MINUTES

On motion of Vice Chairman Henderson and seconded by Councilman Gilbert, the minutes of the last meeting (September 17, 2013) were approved as published.

SPECIAL PRESENTATION

Mr. Travis McDonough with the Mayor's office offered condolences for the loss of two 11 year old boys due to a drowning accident recently and praised the emergency responders (Fire, Police, and EMT) for their dedication and professionalism during the rescue and recovery operation earlier in the week. Chairman Hakeem also offered condolences and praise from the Council as well.

Mr. Andrew Kean formally recognized Fire Chief Lamar Flint to offer the special presentation. Chief Flint asked Councilman Freeman as Chair of the Safety Committee to join him at the podium.

Chief Flint summarized the events of April 2, 2013, and the subsequent actions of several Fire departments during this fire and rescue. He recognized Engine 4, Engine 10, Ladder 4 and Ladder 5 for their professionalism, courageous work and bravery during this event. He offered specific commendation to Captain Dean Rogers and Senior Firefighter Cal Duggan for their work during this event and bravery during the subsequent rescue of two young children from the burning structure.

Chairman Hakeem also offered the praise and commendation from the Council as well and a standing ovation for the two firefighters was given by the assembly.
