CALL TO ORDER

SPECIAL PRESENTATION

Wuxi China Sister City Delegation By Yao Jianhua

Mr. Jianhua made a presentation with the assistance of an English translator. He presented souvenirs from Wuxi to the City of Chattanooga. Chairman Henderson and Councilman Grohn exchanged with the delegation on behalf of the Council. Chairman Henderson also delivered the following proclamation:

hereas: Chattanooga and Wuxi would like to see a stronger business connection

between our cities. Komatsu, Alstom, and Wacker all have factories in Wuxi and the Wuxi delegation will visit McKee Foods, the Chattanooga area's

largest manufacturing employer; and

The Chattanooga- Wuxi relationship provides a strong indicator of our determination to work together to cross geographic, linguistic and cultural barriers. And we are excited that Chattanooga is able to partner with one of China's most advanced cities and we welcome the delegation to our city.
