Mr. Haniszewski indicated that he wished to accept Council's version of the ordinance, not Planning's version. Mr. Herwire verified that he and others representing Opposition had met with Mr. Haniszewski and were satisfied with accepting Council's version.

After further discussion, Councilman Freeman moved to accept Council's version, seconded by Councilman Gilbert. Councilman Mitchell called a *Point of Order*, asking if there was a legal description for the Council version. Mr. Haynes indicated that there was a legal description. The motion carried.
