Mr. Price also voiced concerns about the condition regarding the number of parking spaces. He asked Council to consider amending the condition to "a minimum of .8 parking spaces." Discussion ensued regarding Mr. Price's request. Blythe Bailey, Transportation Administrator, also joined the discussion.

After which, both Councilman Freeman and Councilman Grohn offered to amend the language of the parking space condition, but Chairman Henderson objected because he wanted to hear from the Opposition, if any, before hearing a motion. Seeing that no Opposition was present, Chairman Henderson allowed a motion. Therefore, Councilman Freeman moved to amend the condition to insert a 0.8 minimum requirement of parking spaces be provided for each rentable bed. Councilman Grohn seconded. The motion carried.
