- p.3 Sec. 4.04 Regarding Manner of Voting, add "quorum...majority..."
- p.4 Sec. 4.05 Regarding Quorum, strike "When a quorum is present, a majority of those present in person shall decide any question before the meeting."

Councilman Henderson moved to substitute the resolution, seconded by Councilman Anderson. **Councilman Anderson moved** to approve the resolution, seconded by Councilman Henderson.
