COUNCIL MEETING MINUTES

August 30, 2016 6:00 PM

CALL TO ORDER

Council Chairman Moses Freeman called the meeting to order. A quorum was present, including Vice Chair Jerry Mitchell and Council members Chris Anderson, Carol Berz, Russell Gilbert, Yusuf Hakeem, Chip Henderson, Larry Grohn, and Ken Smith all present. City Attorney Wade Hinton and Council Clerk Nicole Gwyn, CMC, were also present.

PLEDGE OF ALLEGIANCE

Councilman Hakeem led the Assembly in the Pledge of Allegiance.

On motion of Councilman Anderson and seconded by Councilman Gilbert, the minutes of the last meeting (August 23, 2016) were approved as published.

Chairman Freeman opened the floor to Mike Price, who asked to speak on behalf of the Applicant. Mr. Price asked for language to be added to the ordinance: "In the event an alley in the future is requested by the City of Chattanooga, said location would be mutually agreeable to both parties." The Applicant, Mr. Johnston, explained the reason for his request for the additional language.

Councilman Anderson moved to approve, seconded by Vice Chair Mitchell. Discussion ensued with the Applicant and Blythe Bailey, Transportation Administrator.

- Therefore, Vice Chair Mitchell moved to reconsider, seconded by Councilman Anderson.
- **Vice Chair Mitchell moved** to amend by adding the language requested by Mr. Johnston and Mr. Price. Councilwoman Berz stated that the added language was illusory.
- A discussion ensued about a substitute motion to defer so that Chairman Freeman could speak further with the Applicant on this District 8 matter. Chairman Freeman moved to defer for one (1) week, seconded by Councilwoman Berz. Blythe Bailey, Transportation Administrator, contributed to the discussion.

DEPARTMENTAL REPORTS:

Human Resources Department

Administrator Todd Dockery informed the Council that the City is one (1) year into the approval of the resolution and implementation of the Employee Information Guide. He stated that HR is making enhancements to the document and that updates will be provided in September.

Mr. Dockery then introduced Julie Brown, Employee Relations Coordinator, to discuss the division of Employee Relations. He informed the Council of Ms. Brown's background with the City of Chattanooga and gave a brief bio-sketch about her experience in the HR field. Ms. Brown then updated the Council on the following in Employee Relations:

Collaborative Mediation:

- Provides an environment to resolve disputes and provide greater opportunity to communicate between employees and management.
- Completed 16 mediations: 15 resulted in positive and mutual agreements; one (1) mediation did not have an immediate agreement, but was later settled.
- Five (5) pending mediations

Monthly Meetings with SEIU Representatives:

- Have been very successful
- Purpose is to collaborate and address concerns proactively
- Topics include employee concerns/issues
- Meetings provide opportunities where SEIU and management can collaborate
- Meetings provide opportunity for employees to communicate with management
- SEIU holds monthly meetings with managers within various depts.; HR is present to help facilitate discussions between management and employees
- Meetings help strengthen relationships
- Meetings are a great way to be proactive and solution-focused to create a place where employee relations is positive.

Mayor's Family Friendly Workplace Challenge:

- Helps the city understand the importance of balancing work and family
- Examining ways to make Chattanooga a family-friendly workplace: (1) Employee survey completed and (2) Employee Focus Group developed to review and discuss options for addressing challenges (i.e., elderly care, support for military families)
- Goal is for all city employees to feel valued and appreciated
- Invitation to the "Family Friendly Workplace Challenge Summit" on September 8 from 11:00 a.m. to 2:00 p.m. on the campus of BlueCross BlueShield of Tennessee.

Ms. Brown noted that she has received so much positive feedback from employees who tell her how much they appreciate HR's presence and involvement in departments. Attorney Hinton informed the Council that collaborative mediation has been successful in affecting "the bottom line"—expenditures. Due to collaborative mediation, the city has saved approximately \$10,000 that had normally been spent on administrative law hearings.

Councilman Hakeem asked Ms. Brown about training for administrators that have been, historically, unresponsive to employees. Ms. Brown discussed the training opportunities that are available for managers and administrators.
