#### **ORDINANCE #13110**

AN ORDINANCE TO AMEND CHATTANOOGA CITY CODE, PART II, CHAPTER 38, ZONING ORDINANCE, SO AS TO REZONE PROPERTIES LOCATED IN THE 2300 TO 2500 BLOCKS OF GUNBARREL ROAD, 7325 THROUGH 7342 BLOCKS OF MCCUTCHEON ROAD, 2500 BLOCK OF LIFESTYLE WAY, AND 2300 THROUGH 2400 BLOCKS OF ELAM LANE, MORE PARTICULARLY DESCRIBED HEREIN, FROM MXU Mixed Use Zone and R-1 RESIDENTIAL ZONE TO C-4 PLANNED COMMERCE CENTER ZONE, SUBJECT TO CERTAIN CONDITIONS.

**On motion of Councilman Grohn** and seconded by Councilman Smith; Section 11a remove "Any unconnected portions of the pathway must be constructed within three years of this rezoning date."

**On motion of Councilman Grohn** and seconded by Councilman Smith; Section 11c remove "The developer shall bear all expenses related to the acquisition."

On motion of Councilman Grohn and seconded by Councilman Smith; Section 11b add bolded wording -"Due to the additional traffic issues that will be caused by the development at the intersection of Shallowford Road and Napier Road during Phase 2, the intersection must be reconfigured to remove the east bound left turn lane and left turn traffic signal, to add a dedicated south bound right turn lane, and to alter traffic signal phases in order to mitigate the impacts.

On motion of Councilman Grohn and seconded by Councilman Smith; add bolded wording - "When warranted by the development progress during Phase 2, an additional east bound left turn lane must be constructed at the intersection of Shallowford Road and Lifestyle Way to accommodate the anticipated increased traffic turning into the development and Lifestyle Way must be widened to accommodate a corresponding double receiving lane. The City of Chattanooga shall assist procedurally in providing any required additional rights of way."

A RESOLUTION TO MAKE CERTAIN FINDINGS RELATING TO THE GRANTING OF INCENTIVES TO DEVELOP HOUSING IN CHATTANOOGA; TO DELEGATE CERTAIN AUTHORITY TO THE HEALTH, EDUCATIONAL, HOUSING FACILITY BOARD OF THE CITY OF CHATTANOOGA, TENNESSEE (THE "HEB"); TO AUTHORIZE THE MAYOR OF THE CITY OF CHATTANOOGA TO ENTER INTO AGREEMENTS FOR PAYMENTS IN LIEU OF AD VALOREM TAXES MEETING THE CRITERIA OF SAID PROGRAM AND TO PROVIDE FOR A TERMINATION OF THIS INCENTIVE PROGRAM IN TEN (10) YEARS.

A discussion ensued, in which several amendments were made as follows:

**On motion to amend by Councilman Anderson** and seconded by Councilman Hakeem, GENERAL PROVISIONS, First sentence of Section 4 should read, "The PILOT Freeze Period of each project shall be shall be determined by the project evaluation and scoring sheets as determined by the HEB."

**On motion to amend by Councilman Anderson** and seconded by Councilman Hakeem, GENERAL PROVISIONS, Section 5a should read: "Applications must be made on a written form to be promulgated by the HEB, or its designee, and must be accompanied by a \$3,500 fee for administration and processing..."

**On motion to amend by Councilman Anderson** and seconded by Councilwoman Berz, Add to GENERAL PROVISIONS where the City Attorney designates; "A closing fee dedicated to enforcement of all provisions by the appropriate department up to \$15,000."

On motion to amend by Councilman Henderson and seconded by Councilman Grohn, GENERAL PROVISIONS, Section 6 should read: "All PILOT In-Lieu-of-Tax Agreements shall contain mandatory clawback language spelling out what shall happen if the developer does not meet the commitments represented in the PILOT application."

On motion to amend by Councilman Henderson and seconded by Councilman Hakeem, GENERAL PROVISIONS section 7 should read: "All PILOT agreements shall be subject to an annual review and report of status to the City Council."

On motion to amend by Councilman Mitchell and seconded by Councilman Anderson, GENERAL PROVISIONS section 5F should read: If the project on the property subject to a PILOT Lease does not break ground within two (2) years or if the property has been unoccupied for a period of two (2) years, the PILOT Lease will be terminated and the property will be returned to private ownership and full property taxation;

On the friendly amendment by Councilman Anderson and seconded by Councilwoman Berz, Section 3 add - 50% Affordable Units. Not less than 50% of the units developed shall be available at an affordable cost to persons of low and/or moderate income and/or elderly or handicapped persons with 80% percent area median income.
