John Bridger read the C-2 conditions at the request of Councilman Gilbert.

- The C-2 Convenience Commercial Zone portion shall only allow office uses and singlefamily detached residential uses by right, and companion animal hospitals, veterinary offices, pet funeral homes, kennels, animal day care facilities, animal grooming services, and similar uses for small domestic animals by a special exemption permit of the Board of Zoning Appeals;
- No access to South Access Road;
- 3) Dumpsters must be at least one hundred (100') feet from all exterior property lines;

- 4) No smoke stack; and
- 5) No outside kennel overnight.

Councilman Gilbert moved to amend to include the words "indoor only" in condition #5 regarding kennels. He was seconded by Councilman Ledford. The motion carried. **Councilman Gilbert moved** to approve as amended. He was seconded by Councilman Ledford. There was no Opposition. The motion carried. Chairman Mitchell thanked the Human Educational Society (Applicant) for their service to the community.

Therefore, Councilman Henderson requested that the Regional Planning Agency (RPA) facilitate a meeting between educational leaders and constituents to hash out last minute details in the ordinance. Mr. Bridger confirmed that two weeks would be enough time to coordinate a meeting as long as he got the contact information of people to invite to the meeting. Mr. Bridger requested that a representative from the Land Development Office be present at the meeting to get some consensus around changes being discussed, and to help ensure that requested changes were feasible. He also requested the school contacts to make it happen. Councilman Henderson invited anyone who wanted to be contacted for the meeting to stop by the Clerk's desk today to give their contact information.

Councilman Henderson moved for a two-week deferral to June 27, 2017. He was seconded by Vice-Chairman Smith. The motion carried.

RECOGNITION OF PERSONS WISHING TO ADDRESS COUNCIL (Non-Agenda Items)

Attorney Hinton read the rules of procedure for persons wishing to address the Council on non-agenda items. After which, Chairman Mitchell recognized the following persons:

- **Kiah Sheble (Bea Lane)** He voiced concerns about issues with his residential bill for water from Hixson Utility. He had problems with the cost getting higher each month.
 - Ms. Lee explained to the Council how city sewers are being used by Hixson Utility for Mr. Sheble's water service.

- Chairman Mitchell asked Mr. Sheble to meet with Attorney Hinton after this meeting to discuss his billing concerns. Mr. Sheble agreed.
- Mark Mullins (Fairfax Heights/Lupton City/Bagwell City) He is dissatisfied
 with the city's sewage tank to be built 20 yard lines away from his neighbor's yard.
 He displayed a photo that had been shown to the community that, he feels, does
 not accurately show the tank's proximity to residential properties. He agrees with
 the solution, but not the location.
- Danny Grimmet (Bagwell City) He has lived in Bagwell City for over 30 years and read statements he had drafted about the city's sewage tank near his yard. He asked that the City give "due diligence" to this construction project because of the odor, raw sewage and mosquito related to the tank. He would like to see the field logs to see why this location was chosen so close their homes. He informed the Council of raw sewage and other environmental hazards. He informed the Council of 122 signatures of residents in the community who do not want to live next to the tank.
 - o Mr. Grimmet gave a copy of his written statement to Chairman Mitchell.
- Rick Carpenter (E. Brainerd) He voiced concerns about untreated waste getting into water for public consumption via a pipe coming from Soddy Daisy to Chattanooga. He told the Council that this pipe was under the Hamilton County Water and Wastewater Treatment Authority (WWTA) and questioned why the WWTA is not in the city's jurisdiction.
