## **COUNCIL MEETING MINUTES**

August 29, 2017 6:00 PM

## CALL TO ORDER

Council Vice-Chairman Ken Smith called the meeting to order. A quorum was present with Councilpersons Carol Berz, Anthony Byrd, Demetrus Coonrod, Russell Gilbert, Chip Henderson, Darrin Ledford and Erskine Oglesby all present. Wade Hinton, City Attorney, and Nicole Gwyn, Council Clerk, were also present. Council Chairman Jerry Mitchell was not present.

# Community Resource & Job Fair

Councilman Oglesby asked for a *point of privilege* to discuss the upcoming Community Resource & Job Fair on Thursday, August 31, from 10:00 a.m. to 3:00 p.m., taking place at Olivet Baptist's Kingdom Center. He informed the Council that four individuals participating in the job fair were present to give information about the fair and asked to hear from them.

Jacqueline Griffith of the State of Tennessee's Child Support division informed the Council that there would be over 30 entities providing job opportunities and other services at the far. Councilman Oglesby inquired about some of those services, such as driver's license reinstatement. Ms. Griffith informed the Council that two attorneys would be available to help individuals get their driver's licenses reinstated and also help get criminal histories expunged.

Councilwoman Coonrod inquired about the attorneys helping people with citizen restoration. One of the participating attorneys was present and informed the Council that citizenship restoration would not be addressed at the job fair.

# RECOGNITION OF PERSONS WISHING TO ADDRESS COUNCIL (Non-Agenda Items)

Attorney Hinton read the rules of procedure for persons wishing to address the Council on non-agenda items. After which, Vice-Chairman Smith recognized the following persons:

• Franklin McCallie (Reed Avenue/District 7) – He felt it was appropriate to express his sadness over the displacement of so many residents in Texas due to Hurricane Harvey. He suggested a discussion on what we have learned from the national disaster. In 2016, he informed the Council that the water regulations were decreased from 2" to ½" to be contained on individual property. He noted an article by Dave Flessner in the Chattanooga Times Free Press that discussed a proposal "to ease the requirements for new developers and builders to retain so much rainwater runoff in the South Chickamauga Creek and to mandate so much remediation and controls on properties dug up for new projects across the rest of the city." Mr. McCallie also read an excerpt from an article by Pam Sohn in the Chattanooga Times Free Press that argues against easing stormwater regulations for the sake of economics. Mr. McCallie asked the Council not to rush into lessening a necessary regulation. He noted that no homeowner or business owner would want raw sewage on their property.
