1) Limit the total number of units allowed on the site to twelve (12) townhouses; and

2) There shall be no development, with the exception of removals and restoration for the purposes of installing a retaining wall indicated on the attached site plan, north of a line described as connecting two (2) points "A" and "B". Point "A" to be located along the north western property line, one hundred seventy-five (175') feet south of its northern most point. Point "B" to be located along the eastern (Beason Drive) property line, fifty (50') feet south of its northern most point.

Councilman Henderson informed the Council that one line in the agreement had been added already to the ordinance they were currently on that read: "...the Project will be constructed in substantial compliance with the project description set forth in the PILOT Application that the Company submitted to the City as determined by the Land Development Office of the City and in consultation with the County."

Councilwoman Coonrod asked Donna Williams, Administrator for the Department of Economic and Community Development, about the PILOT process and what this PILOT will be used for. Ms. Williams explained the required investment in a PILOT project, the current rate and school portion from that rate, the minimum investment by the developer and percentage of the rental rate and average median income. She responded to questions from Councilwoman Coonrod on how the City and County both have their approvals for a PILOT, what happens when a PILOT is not fulfilled and the annual compliance portion. She also responded to Councilman Byrd's question about what happens if this property is sold. Upon no further questions, the motion carried.

Councilman Gilbert reminded the Assembly that the Council meeting next Tuesday (October 2) would start at 4:00 p.m. instead of 6:00 p.m. due to Council members participating in National Night Out events in their districts.

Councilman Gilbert spoke recently at an event with Brainerd High School students, where the students discussed voting. He challenged everyone to vote. He noted that it only takes 10 minutes of your time to vote. He emphasized that everyone's vote counts.

RECOGNITION OF PERSONS WISHING TO ADDRESS COUNCIL (Non-Agenda Items)

Attorney Noblett read the rules of procedure for persons wishing to address the Council on non-agenda items. After which, Chairman Smith recognized the following persons:

- Christopher Dahl (Chattanooga) Mr. Dahl wanted to address the PILOT for Jaycee Tower. He reminded everyone that the PILOT had been agreed by the City and County. He informed the Council that the company received the PILOT to perform renovations at the tower, but once they did, the company began putting residents out rather than make requested repairs. From what he was told, people's furniture got thrown out the window due, in part, to bed beg issues and some of it got stolen in the process. He indicated that debris was thrown from very high windows. It was reported that nothing was done about it. He indicated that many people were Furniture stolen in lobby, but the company sent someone door-to-door to talk to the elderly people living there. He also informed the Council about maintenance issues at the building. When he asked questions of the manager, he was told by the property manager that the mayor had authorized bringing homeless people to the tower so that they would not be seen by tourists downtown. He indicated that people are moved from one unit to the next to avoid making repair. After some clarifying questions from Councilwoman Coonrod about the name of the facility, Mr. Dahl informed the Council about seniors coming to the Council meeting next week to speak about issues at this building. He indicated that the PILOT deals happen, the public is not aware. He indicated that PILOT deals are being done with companies that overseas. He said the Health, Educational and Housing Facility Board (HEB) makes leasing agreements with private companies that the public is never told about. He believes the public should know about the lease agreements by this entity.
 - Councilwoman Coonrod asked Ms. Williams of ECD to discuss the leasing process. Ms. Williams explained that a public housing authority issued the Jaycee Tower PILOT. This Council body was not required to issue the PILOT. The public housing authority partnered with a private developer. State statute requires transfer of ownership to the HEB. They meet once a month with an agenda that is public. The public often comes. It is publically advertised.
 - Regarding Ms. Dahl's concerns about homeless people at the Jaycee Tower, Ms.
 Williams believes it is unlikely that homeless people are living rent-free in the
 building. Residents pay up to 30-percent of their income. If they're accepting
 homeless people, that would not be consistent with the funding mechanisms in
 place.
 - o Mr. Dahl indicated that people in the tower are having trouble getting to the doctor and says that some of them have mental challenges. He said that one 80-year-old resident is having trouble getting to doctor's appointments and will come down to the Council meeting next week to address these issues.

- Isaiah Moore (Chattanooga) He asked the Council rhetorical question: where are your hearts? He believes that the police are not being held accountable for their wrong actions. He asked the Council to consider if it had been their daughter pulled from a car. He reminded the Council that they are supposed to be for the people. He argued that more should be done within inner-city communities. Although he sees more police in the community, he does not believe the VRI [Violence Reduction Initiative] has helped, especially for black families. He informed the Council of a man being called the "N" word for speaking up. He feels that the Council is giving power to the police, keep burning a blind eye to the police and not holding them accountable. He believes that saying that there are two sides to a story. He believes that if he assaulted a woman, he would be sent to jail with no investigation. With all the money being passed by the Council, he asked: Where are your hearts?
 - Councilwoman Coonrod made comments about a black person she knew who was murdered recently by another black person. She argued that a conversation should be held within the community about preventing black-on-black crime. She discussed issues among some people in the community. Mr. Moore attempted to address those points made by the councilwoman and questioned what she had done to help the community that helped elect her to office. When the conversation between Councilwoman Coonrod and Mr. Moore became disruptive, Chairman Smith asked Councilwoman Coonrod to yield the floor. After which, Chairman Smith opened the floor for the next person wishing to address the Council.
- Marie Mott (Chattanooga) Ms. Mott read a quote from Harriet Tubman and informed the Council that she would not stop regardless of not being allowed to speak in this venue. Her ancestors kept going, that's why she must. She takes her own time and money to work for the community. She brought Mr. Moore today to speak. She takes her own energy, time and money to work for her community. She's a product of chattel slavery. She sees why Chattanooga is listed as the 7th worst-run municipality. She stated the she relishes in insurrection when it is in the best interest of her people. She knows that her persistence rubs people in the wrong way, that people have made inquiries about her and that people have tried contacting her under false pretenses. She expressed being undercut her at every turn, yet she keeps going and encourages youth to keep going. She believes that her people may have been removed from the dogs and chains of slavery, but they haven't been removed from the struggles of America. A Council member told youth to buy a home, but the Council has allowed the city to be gentrified so that youth cannot afford a home. Her grandfather worked at U.S. Pipe for over 52 years, but her family has trouble holding on to their house because housing is skyrocketing. She discussed the realities of "two Chattanoogas." She believes the Council is living in an illusion and does not know what is happening in the community, even though the people have been talking about police actions for the past three months. She questioned why the Mayor is not sitting on the dais with the Council in these meetings. She discussed Council people involving the name of God, but not showing love through their legislation actions. She gained knowledge of PILOTs and TIFs from Helen Burns Sharp, a fellow citizen, than she did from the Council. She informed the Council that when the tide of change comes, they will be swept away.
- **Mahmood Abdullah** (District 7) Mr. Abdullah expressed his support for Ms. Mott. He told the Council that the games must stop. He took exception to councilpersons telling people to "pull themselves up by their boot straps" when some people, he noted, do not have boots in the first place. He noted how people are being accused by those who are doing far worse actions. He noted that God will judge the actions of the Council. He feels that some councilpersons should be ashamed of themselves.

- Gary Ball (Chattanooga) He is representing his company, Tower Construction, and the Ridgedale Community Association. He believes it is a privilege to come down and speak, and that all citizens have the right to speak to what the government is and is not doing. He came today because he wanted to follow-up on the letter from July 27 that he presented to the Council regarding the City Attorney's opinion on a state law and two months have passed with no further discussion. He will go to the County Commission on Thursday to say the same to them. His only option is to send it to the State Attorney's Office to see if they want to tell anybody other than the current decision-maker as to what is allowed. He is also involved with a surplus property program for affordable housing under ECD. He learned that the gentleman running the surplus property program is also an attorney. He questioned whether the man running the program is wearing the hat of an attorney or is representing the interests of the community. This man seems to be driving the issues with liens and surplus properties. If the City forces them to pay for the surplus property, then demand that it be used for affordable housing, then he and his son will not pursue the surplus property. CNE is operating as a developer. He found out that his company has six developments in Ridgedale and CNE has six in Ridgedale. After finding that out, he learned that CDOT told CNE they could do something other than what the ordinance says regarding street cuts. Lastly, he is working with a Hispanic gentleman who got into a situation building a tree house without a permit and had some problems with codes. This individual is waiting for a decision on why CNE can do a detached, two-story structure and tie it together with a breezeway, but this gentleman has been told by the city to tear down his tree structure. He is willing to help the man build the tree house to city standard, so he asked the city to offer the same compassion for this Hispanic man as for the man building for CNE.
 - Councilman Byrd asked Ms. Williams of ECD to give clarity. She asked Mr. Ball to come to her office any time to ask questions about these matters. Jonathan Butler. the current Manager of Neighborhood Services and Development for the City. He is a licensed attorney in good standing, authorized to practice law in Virginia and Georgia. She indicated that he does not handle affordable housing. She informed the Council that the public housing authority makes lease agreements with private companies. She indicated that the State constitution does not allow for the forgiveness of back taxes. Once property is surplused, whoever buys it pays the taxes. There are circumstances when the city will consider removing a lien on a property, but taxes cannot be forgiven. Mr. Ball's company has done a good job with those properties. Someone does not have to be eligible for federal money through the back-tax sale. The buyer can do as they wish with the property. She again asked Mr. Ball or anyone else doing business with the city to come to her office with their questions. In Highland Park, she informed the Council that the Land Development Office did put a stop-work order against a developer who trying to build an unauthorized accessory dwelling unit. The developer complied and stopped the work as ordered. She could not, however, speak to the incident with the man building a tree without a permit.
 - Mr. Ball indicated that there are city back taxes and county property sale. His letter
 was explicit in that the county property sale is not a back tax sale. Chairman Smith
 asked Mr. Ball to continue with his questions with Ms. Williams after tonight's
 meeting.
- Ron Ray (Lookout Valley) He prepared remarks a few weeks ago, but was unable to make them at that time. He gives credit where credit is due. He expressed his gratitude to the council members, who have conducted themselves in a professional manner. He has served as a citizen watchdog over city government and elected leaders. He indicated that he is not naive to believe in utopia though. He is honored to call Chattanooga home. The

council has placed itself above reproach. He asked the council to create oversight over road enterprises as an open and transparent way to scale back undue criticism. He applauded the professionalism of the council and attested to several council members and assured that their first concern is accountability. He commended his own Council representative, Councilman Henderson, for always reaching out to both sides of an issue in their community. He is sure that the people are his employer. He noted the fairness of Councilman Ledford and being above reproach. He commended Councilman Byrd and Councilwoman Coonrod as handling themselves in a respectful way and watching out for the citizens that they serve. He believes the Council should remain humble in listening to citizen concerns. He believes both sides need to work together, but the public side should also offer solutions to help the Council.

- David Tullis (Chattanooga) He informed the Council about Noah Macklemore III, owner of a shoe store on Highway 58, who was standing in front of his business one day. Mr. Tullis indicated that Mr. Macklemore had three things against him as he stood that day: (1) he was dragging on a cigarette, (2) he wore a white "wife beater" tank top, and (3) he was a dark-skinned African American man. He indicated that a police officer came to Mr. Macklemore with a gun drawn to interrogate him. He questioned why the officer would call for back-up—three police cars, one with sirens blaring—if she only needed to ask him some questions. He described the process by which Mr. Macklemore was questioned and pat-down by the one officer while other officers stand around. He indicated that Mr. Macklemore is now having a hard time doing his business. When he tried to interview Mr. Macklemore for his online news outlet, Mr. Macklemore broke down crying. He indicated that Mr. Macklemore is a victim of the routine and that the interrogation is unremarkable unless you watch the actual video on Facebook. He believes social media is a remedy for seeing what's really going on in the community. Mr. Tullis believes that what happens on the city level matters more than in Nashville or Washington. He spoke to an executive at the Chamber recently to show how such negative police interactions affect the entrepreneurial spirit of business men. He believes that minorities are built in to be afraid. He encouraged people to go to his news outlet, nooganomics.com, to see the 8-minute video that Mr. Macklemore shot of his interrogation. He believes the officer should have asked questions without having to make demands or exercise authority. The officer could have negotiated to get the facts she needed without coming with her gun drawn and patting him down. The officer demanded that Mr. Macklemore come to her car and give him her social security number, even though Mr. Macklemore told the officer that he had his business license in the store. Mr. Tullis emphasized the need for de-escalation by the police.
- Kevin Scarborough (Hickory Valley Rd./District 6) this is his first city council meeting. He read about CPD's presentation last week about violent crimes, broken down into districts. He lives in 37421 and was surprised, like Councilman Ledford, to see 37421 as the second most violent zip code in Chattanooga. During clarifying questions from Councilwoman Berz, Mr. Scarborough described hearing shots fired around midnight last night. Not used to hearing in his neighborhood. A call was placed to 911 at 11:49 p.m. last night. He called CPD this morning and found that a unit did respond and made contact with an individual.
 - Councilwoman Berz said that on 2nd Thursday of every month at the Family Justice Center, there is a CPIC meeting. Violence in their area has to do a lot with domestic violence. He is pleased with him wanting to be part of the solution. She invited him again to come to CPIC meetings. However, she noted that the meeting will not take place in October because of National Night Out events taking place. At the meeting, she indicated that citizens talk about crime with the police. She asked for Mr. Scarborough's contact information so that she can get it to those who

distribute the public meeting notices. Assistant Chief McCullough further elaborated that the heads of the neighborhood groups and members of the public come together to discuss crime with CPD. He informed the Council that Sgt. Wayne Jefferson at CPD coordinates the public notice and can add Mr. Scarborough to their meeting notices.
