# RECOGNITION OF PERSONS WISHING TO ADDRESS COUNCIL (Non-Agenda Items)

Attorney Noblett read the rules of procedure for persons wishing to address the Council on non-agenda items. After which, Chairman Smith recognized the following persons:

- Amir Ashmabay (Chattanooga) He informed the Council that he has been going through many things like others in the community. He is tired about being falsely accused. He believes his arrests have been falsified. He believes there has been official oppression against him. He has spoken to Council members and some of them are aware of what he's been going through, as well as what he's been doing to help the community. His mother is in a nursing home and he has not seen her in four years because of the cases against him. He wanted to end on a positive note by telling about the millions that have been invested in him.
- Marie Mott (Oak Grove) She watched the stormwater fee presentation online and heard that the County and UTC owe money to the City of Chattanooga. She heard one councilperson call that money "illusory debt." She cannot understand why entities and corporations do not pay back money owed to the City, yet, the City will put people out of their homes for back taxes. She believes that if the County and UTC debts are paid back to the City, then that would ensure the fairness of checks-n-balances. She does not believe it is an expectation of taxpayers for these entities not to pay their debts. She asked the Council to pursue getting these funds from these entities.
- **Tiffany Rankin** (Lincoln Park) She attended a November 8<sup>th</sup> neighborhood meeting that her representative, Councilman Byrd, also attended with his family. There was a discussion at that meeting about \$2 Million for the greenspace. The meeting became heated, to the point where she felt that Councilman Byrd disrespected one citizen. She also was approached after the meeting by someone in Councilman Byrd's family who was upset with her. She was upset that Councilman Byrd is people to their neighborhood meetings who do not live in the district.
  - During her comments, Chairman Smith reminded Ms. Rankin to address her comments during this portion of the agenda to the full Council. Ms. Rankin complied and continued discussing the neighborhood meeting in general.
