COUNCIL MEETING MINUTES

December 18, 2018 6:00 PM

RECOGNITION OF PERSONS WISHING TO ADDRESS COUNCIL (Non-Agenda Items)

Attorney Noblett read the Council's authority under the City Code as well as the rules of procedure during this portion of the agenda. After which, Chairman Smith recognized the following persons:

- Tiffany Howard (Conyers, GA) She informed the Council of an incident on October 14, 2018 when she called 911 for assistance. The incident involved two (2) Chattanooga police officers and one (1) paramedic. She stated that she was injured in the incident and described those injuries for the Council. She informed the Council of a Tennessee law that allows officers to determine if a person is a danger to themselves or others and informed the Council that officers on the scene deemed her as "mentally incompetent" that day, yet, allowed her to retrieve her phone from her purse at the scene, which could have put the officers' lives in danger. She filed an Internal Affairs complaint detailing this incident. She believes the actions of the officers in question were a violations of the orders and expectations of their police chief. She discussed the officers' actions in terms of minority police recruitment, cost to taxpayers and hindrance to business in the city.
- Marie Mott (Chattanooga) She read excerpts from Dr. Martin Luther King, Jr.'s 1967 "Beyond Vietnam" speech. She discussed her perception of the Council using lack of jurisdiction in "passing the buck" last week by not calling for action in the Hamilton County police incident. She named several police-related incidents within the Council's jurisdiction. She believes the Chair of the Public Safety Committee has gone silent on these issues. She reminded the Council that they are elected to do the will of The People. She informed the Council that people riot when they lose faith. She feels that others do not understand black people's pain. She asked the Council to wake up and do what is right.
