RECOGNITION OF PERSONS WISHING TO ADDRESS COUNCIL (Non-Agenda Items)

Attorney Malueg read the rules of procedure for persons wishing to address the Council on non-agenda items. After which, Chairman Smith recognized the following persons:

Tom Slatten (Soddy Daisy) – Mr. Slatten is an employee of the City of Chattanooga's
Public Works Department. He informed the Council of working recently at the Fleet
Maintenance and being denied the ability to use the restroom while at the facility. He
spoke to the manager, who did not give a reason as to why he, a city employee on
business at the facility, could not use the restroom. He was told at one point that there was
a female employee who used the restroom. However, Mr. Slatten questioned why one of
the restrooms there could not be unisex.

- Councilman Mitchell, Chair of the Public Works and Transportation Committee, asked Donald Stone, Deputy Administrator for Public Works, to look into this situation.
- David Tullis (Chattanooga) He is an announcer for 92.7 Radio. He reminded his notice to the Council about Title 55 on Transportation. He thinks that the Frederico Wolfe case from March 10, 2018, is an example of why police stops are dangerous for both citizens and officers. He noted one resource indicating that police stops are more dangerous than domestic violence. He believes the City cannot enforce the Transportation statute. He believes the city is acting in bad faith and without a care. He would like for Chattanooga to be a sanctuary city against abuse of Transportation law. He asked for a stop in the abuse of people this law. He noted one resource indicating that blacks are sixty-percent more likely to be stopped for traffic violations. He would like a free market on the use of the roads.
