#### **COUNCIL MEETING MINUTES**

February 5, 2019 6:00 PM

#### CALL TO ORDER

Council Chairman Ken Smith called the meeting to order with Vice-Chairman Erskine Oglesby and Councilpersons Carol Berz, Anthony Byrd, Demetrus Coonrod, Russell Gilbert, Chip Henderson, Darrin Ledford and Jerry Mitchell. Phil Noblett, City Attorney, and Nicole Gwyn, Council Clerk, were also present.

Councilman Mitchell led the Assembly in the Pledge of Allegiance.

## Proclamation, "Zeta Phi Beta Sorority, Inc." By Councilwoman Demetrus Coonrod

He made further comments on the precedence he feels will be set by the passage of this resolution. Councilwoman Berz called a *point of order* about the main motion on the table and did not think discussion could be allowed. Chairman Smith ruled to allow discussion from the Council. Councilwoman Berz asked Ms. Sullivan about how to handle the services if this is tabled. Ms. Sullivan discussed going back to the drawing board if tabled and noted some timing consideration.

# RECOGNITION OF PERSONS WISHING TO ADDRESS COUNCIL (Non-Agenda Items)

Attorney Noblett read the rules of procedure for persons wishing to address the Council on non-agenda items. After which, Chairman Smith recognized the following persons:

- Christopher Dahl (District 9) He's been gone for a while, but has been following
  what is happening with due process regardless. He has been researching federal
  funding block grant and Weed-n-Seed programs and will turn over the research to
  the U.S. Office of Government Accountability and other federal agencies regarding
  misuse of federal funding.
  - Councilwoman Coonrod asked Mr. Dahl to discuss the research he had done on the misuse of federal funds. Mr. Dahl indicated that he knows about several programs, not just the two that he mentioned, where he has reports and will turn them over to the proper authorities who deal with the misuse of funds. He also spoke on the original intent of the Weed-n-Seed program.

- Melissa Manwaring (District 9) She came in December for her STVR
  application on Kirby Avenue andit was denied. She was told that no STVR wanted
  in Highland Park. She thinks it is arbitrary that some applicants can have
  applications approved fi there is no opposition.
  - Councilwoman Coonrod commented on the fact that Ms. Manwaring had not spoken to the community about her STVR, which led to her moving to deny it. Ms. Manwaring commented on her efforts since then to attend the association meetings.
