COUNCIL MEETING MINUTES

March 8, 2022 6:00 PM

CALL TO ORDER

Council Chairman Chip Henderson called the meeting to order. A quorum of eight was present that also included Vice Chairman Ken Smith and Councilpersons Carol Berz, Demetrus Coonrod, Raquetta Dotley, Isiah Hester, Jenny Hill, and Darrin Ledford. Caleb Fisher, Codes Inspector, gave a presentation with information on the following:

- Application history

Applicant:

• **Lorelei Fischer** – She brought pictures for the I.T. team to project for the Council. She discussed why she and her husband purchased the property. She discussed all of the concerns of the four letters of objection, which included concerns about the deterioration of the neighborhood character, safety, effect on home values, traffic speeding, and others.

Opposition:

- **Tim Osborne** He spoke on how this STVR does not help the neighborhood or build relationships with the neighbors. He likened this STVR to a hotel dropped in their neighborhood.
- **Elaine Clark** She discussed the number of STVR letters coming to her and her neighbors and the saturation in her community. She researched the Airbnb website and found 96 STVRs within a one mile radius of her home.
- Lee Griffith She lives across the street from this property and is concerned with the saturation of STVRs on their street. She is also concerned about STVR owners in nonoccupied STVRs not being able to participate in the day-to-day activities of the neighborhood.
- **Victoria Bates** She has lived next door an approved STVR for three years now and considers it as an annoyance. She appreciates having met with the Applicant, but does not want another STVR in the neighborhood.

Councilwoman Hill noted that there was now five letters of objection for this STVR. She discussed her commitment to transparency in the process and future work that is needed to improve the STVR process. Upon no further discussion, **Councilwoman Hill moved** to approve. Vice Chairman Smith seconded. The motion carried.

OTHER BUSINESS

Certificate of Compliance

Attorney Noblett reported on the following business applying for a Certificate of Compliance: Campbell Miracle, LLC d/b/a Dragon Wine and Spirits – Certificate of Compliance for liquor store (District 4). He informed the Council that the RPA (Regional Planning Agency) determined that this particular location is within 286 feet of a daycare center, which would be in violation of the ordinance if the certificate is granted. Therefore, RPA recommended to deny this certificate, which is what brings it before the Council tonight. He noted that there must be some action taken by the Council within a 60-day time period or the application would be approved.

Vice Chairman Smith moved to deny. Councilwoman Hill seconded. The motion carried.

Settlement of Claim

Attorney Noblett reported on a settlement for \$36,000.00 in connection with a claim by Deandra Jackson for an automobile accident. His recommendation was based upon the attorneys on the other side and the negotiation that has occurred. He asked the Council if there was any objection to this settlement. There was no objection from the Council.

District 8 Interim Appointee

Chairman Henderson explained the process for nominating and voting on the Interim Appointee for District 8. Five applicants were nominated.
