Carter and Senator Gardenhire spoke to the work that has been done in Chattanooga in getting this moving and how happy they were with the precedent being set in this city. Ms. Jeffery also gave the Council an update on the work that her department has done and introduced Mr. Phillips, who spoke to her department's role in the program. Councilpersons Henderson, Ledford, Gilbert, Byrd and Oglesby all expressed words of gratitude for work being done for the "Take Me Home Program."
