Approval of Minutes

- Councilwoman Coonrod questioned who the contact involves and the language of the contract. She inquired as to why the City contracts with Santek and asked for clarification from Councilman Gilbert about his specific concerns.
- Councilwoman Berz inquired about the number of city contracts with Santek and their subsidiaries.

- Councilwoman Coonrod stated she wanted the Racism as a Public Health item to be put on the agenda. Councilman Mitchell and Councilwoman Berz asked to discuss the resolution prior to adding to an agenda. Vice-Chairman Smith offered to discuss the resolution during the next Legislative Committee.

- Councilwoman Coonrod inquired from Mr. Noblett about drafting the "8 Can't Wait Reform" as a resolution. Mr. Noblett discussed elements of the reform that had already been implemented by the Chattanooga Police Department.
- Councilman Mitchell asked about what the Council was looking to achieve with the Racial Equity Training and was hoping to have a discussion on providing better services during the Council meetings for the hearing impaired. The Chairman asked the Clerk to add these items to the next Strategic Planning Meeting.
