Call to Order

Council Chairman Darrin Ledford called the meeting to order at 2:33 p.m. in the Assembly Room of the John P. Franklin Sr. City Council Building. A quorum was present that also included Vice Chair Raquetta Dotley and Councilpersons Chip Henderson, Isiah Hester, Jenny Hill, Ken Smith, Carol Berz, Demetrus Coonrod and Marvene Noel.
