City Code Chapter 31: Changes

Proposed ordinance changes:

Chapter 31-4: Sewer lateral changes

Chapter 31-14: Change to connection point for separating communal private sewer laterals



City Code Chapter 31- 4: Changes

- City will repair or replace broken or damaged four inch and smaller wastewater laterals within the City Right-of-Way
- Customer's plumber must make every effort to clear blockages
- Customer video verification of breaks or damage within the right-of-way is required
- Customer to provide a bi-directional cleanout at the right-of-way line prior to City repairs, if one does not already exist.



City Code Chapter 31- 4: Not changing

- Laterals outside the right-of-way (on private property) remain the customer's responsibility.
- Laterals larger than 4 inches in diameter (commercial, multifamily, industrial, etc.) remain property owner responsibility.
- Laterals on private property or in easements remain property owner responsibility regardless of size.



City Code Chapter 31- 4: Not changing

- Only affects properties connected to the City of Chattanooga
 wastewater collection system. Private sewers or sewers owned by
 other utilities are excluded.
- Installation of new service connections are the responsibility of the property owner all the way to the main, regardless of location.
- Lateral obstructions created by roots, grease, rags, etc., that can be cleaned or removed remain the responsibility of the property owner.



Customer Process

STEP 2 STEP 4 STEP 1 STEP 3 **Property** Plumber Wastewater Repair is staff reviews performed owner calls confirms problem and 311 to submit plumber's once installs the request confirmed data and cleanout contacts (if necessary) owner

City Operational Approach

- Initially, repairs will be made using existing city blanket contracts for sewer and pavement repairs.
- A new blanket contract specifically for this service will be created.
- Certain repairs may also be made by City crews as resources allow.
- Customers will initiate the process by calling 311 once their plumber has inspected the lateral and installed the cleanout, if necessary.



Damage Claims

- Any claims related to damage caused by sewer lateral issues where the City has accepted maintenance responsibility can be filed with the City attorney's office (OPTION 1 FOR BILL P.)
- Any claims related to damage caused by sewer lateral issues within the Right-of-Way may be filed with the City Attorney's Office; however claims related to obstructions that can be removed may be denied.
- Damage due to a sewer backup may be reimbursable by the City
