This was an open meeting. Full audio was recorded and filed with the Clerk of the Council's Office. A discussion ensued with City Attorney Wade Hinton on the following:

### Update on Animal Control Ordinance

Attorney Hinton discussed concerns brought to the Animal Control Board (ACB) from hobby breeders. Attorney Foster highlighted some of the changes to the ordinance; she referenced a "red-lined" documents that had been emailed to Council. She noted the following revisions:

- Removing requirement for vaccination
- Exclusion for vaccinations with signed authorization by a vet
- Notification for micro chips (to microchip manufacturer only)
- Vets could diagnose problems in animals
- Permit for restaurants changed to reflect "...any Dog that resides.."

Councilman Freeman recommended moving the Animal Control Ordinance to the agenda for November 11<sup>th</sup>. Vice Chair Dr. Berz called a Point of Clarification: She wanted to know when do violations go to the City Court or the ACB? Attorney Hinton responded on the powers of the ACB. Attorney Foster responded on how jurisdiction would determine where violations would be heard. Discussion continued about adjusting the fine to make it stronger in enforcement. Council resolved that the ordinance would appear on the November 11<sup>th</sup> agenda and, if passed, will be effective November 30<sup>th</sup>. It was noted that Councilman Grohn and Councilman Anderson will be absent during the second reading of the ordinance.
