ORDINANCE NO. 11456

AN ORDINANCE CLOSING AND ABANDONING THE 2900 BLOCK OF ANDERSON STREET AND A PORTION OF THE 800 BLOCK OF BOYD STREET, MORE PARTICULARLY DESCRIBED HEREIN AND AS SHOWN ON THE MAP ATTACHED HERETO AND MADE A PART HEREOF BY REFERENCE, SUBJECT TO CERTAIN CONDITIONS.

SECTION 1. BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHATTANOOGA, TENNESSEE, That there be and is hereby closed and abandoned the 2900 block of Anderson Street and a portion of the 800 block of Boyd Street, more particularly described below and as shown on the map attached hereto and made a part hereof by reference:

Abandonment of the 2900 block of Anderson Street beginning at the east line of the 800 block of Kyle Street and extending some 623 feet to the west line of the unopened 800 block of Celia Street. Said street separates Lots 126 and 127, Carey's Addition to Ridgedale, Plat Book 1, Page 38, ROHC, from Lots 20 thru 23, Glover's Subdivision Revised Plat of W. H. Converse, Plat Book 7, Page 12, ROHC. Tax Map 156D-A-010 thru 011 and 156D-G-011 thru 014.

Abandonment of a portion of the 800 block of Boyd Street beginning at its intersection with the north line of the 2900 block of Anderson Street and extending some 188 feet northeast to the north line of lot 130, Carey's Addition to Ridgedale, Plat Book 1, Page 38, ROHC. Said street separates Lots 123 thru 126 from Lots

127 thru 130, Carey's Addition to Ridgedale, Plat Book 1, Page 38, ROHC. Tax Map 156D-A-007 thru 013.

SECTION 2. BE IT FURTHER ORDAINED, That this closure and abandonment shall be subject to the Electric Power Board, Tennessee-American Water Company, Comcast Cable Communications, Inc., BellSouth Telecommunications, Inc., Chattanooga Gas Company and the City of Chattanooga maintaining their respective easements for the full width and to allow full ingress and egress.

SECTION 3. BE IT FURTHER ORDAINED, That this Ordinance shall take effect two (2) weeks from and after its passage, as provided by law.
