ORDINANCE NO. 11621

AN ORDINANCE CLOSING AND ABANDONING A RIGHT-OF-WAY AT THE 2800 BLOCK OF ROANOKE AVENUE BETWEEN CUSHMAN STREET AND BACHMAN STREET, MORE PARTICULARLY DESCRIBED HEREIN AND AS SHOWN ON THE MAP ATTACHED HERETO AND MADE A PART HEREOF BY REFERENCE, SUBJECT TO CERTAIN CONDITIONS.

SECTION 1. BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHATTANOOGA, TENNESSEE, That there be and is hereby closed and abandoned a Right-of-way at the 2800 block of Roanoke Avenue, more particularly described below and as shown on the map attached hereto and made a part hereof by reference:

Abandonment of a portion of the 2800 block of Roanoke Avenue beginning at the northeastern most corner of Lot 1, Corrective Plat of the Revised Plan of Lot 5 and 2<sup>nd</sup> Revised Plan of Lot 1, John R. Evans Subdivision of Block 11, Anderson's Addition to East Chattanooga, Plat Book 74, Page 21, ROHC, thence continuing southwest some 140 feet to a dead-end. Said right-of-way separates Lot 1, Corrective Plat of the Revised Plan of Lot 5 and 2<sup>nd</sup> Revised Plan of Lot 1, John R. Evans Subdivision of Block 11, Anderson's Addition to East Chattanooga, Plat Book 74, Page 21, ROHC, from Lot 7, Block 12, Anderson's Addition to East Chattanooga, Plat Book 3, Page 12, ROHC. Tax Map 127M-K-008 and 127M-M-025.

SECTION 2. BE IT FURTHER ORDAINED, That this closure and abandonment shall be subject to EPB, Tennessee American Water Company and the City of Chattanooga retaining full access easements for the full width of the right-of-way.




