ORDINANCE NO. 11632

AN ORDINANCE CLOSING AND ABANDONING A PORTION OF AN UNNAMED ALLEY BEGINNING ON THE WEST LINE OF THE 3800 BLOCK OF HIGHLAND AVENUE, MORE PARTICULARLY DESCRIBED HEREIN AND AS SHOWN ON THE MAP ATTACHED HERETO AND MADE A PART HEREOF BY REFERENCE.

SECTION 1. BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHATTANOOGA, TENNESSEE, That there be and is hereby closed and abandoned a portion of an unnamed alley beginning on the west line of the 3800 block of Highland Avenue, more particularly described below and as shown on the map attached hereto and made a part hereof by reference:

Abandonment of a portion of an unnamed alley beginning on the west line of the 3800 block of Highland Avenue thence northwest 181.7 feet to the northeastern most corner of Lot 10, Subdivision of the north part of the Roger's Home Place at Alton Park, Plat Book 6, Page 60, ROHC. Said alley separates Lot 10(part) and Lot 11 from Lot A and Lot B, Subdivision of the north part of the Roger's Home Place at Alton Park, Plat Book 6, Page 60, ROHC. Tax Map 155N-M-004, 005 and 006.

SECTION 2. BE IT FURTHER ORDAINED, That this closure and abandonment shall be subject to Tennessee American Water Company retaining their respective easement in the full width of the abandoned alley.

SECTION 3. BE IT FURTHER ORDAINED, That this Ordinance shall take effect two (2) weeks from and after its passage, as provided by law.

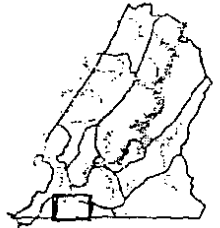
MR ABANDON ALLEY R-O-W
