AN ORDINANCE TO CHANGE THE RIGHT-OF-WAY NAME FOR PART OF THE 2300 BLOCK OF TIMBERLANE TRAIL TO LIFESTYLE WAY, MORE PARTICULARLY DESCRIBED HEREIN AND AS SHOWN ON THE MAP ATTACHED HERETO AND MADE A PART HEREOF BY REFERENCE.

SECTION 1. BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHATTANOOGA, TENNESSEE, That the right-of-way name for part of the 2300 block of Timberlane Trail be and is hereby changed to Lifestyle Way, as shown on the map attached hereto and said right-of-way being more particularly described as follows:

Right-of-way name change for part of the 2300 block of Timberlane Trail to Lifestyle Way beginning at its intersection with the north line of the 7300 block of Shallowford Road thence extending northeast some 550 feet to a dead-end. Tax Map 149H-A-019 and 149H-G-001 and 002.

SECTION 2. BE IT FURTHER ORDAINED, That this Ordinance shall take effect two weeks from and after its passage.

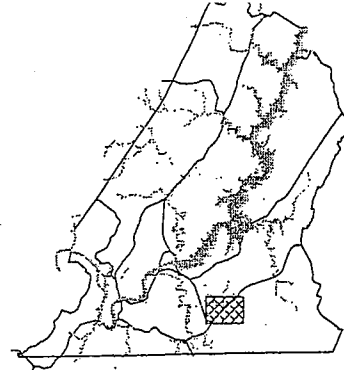

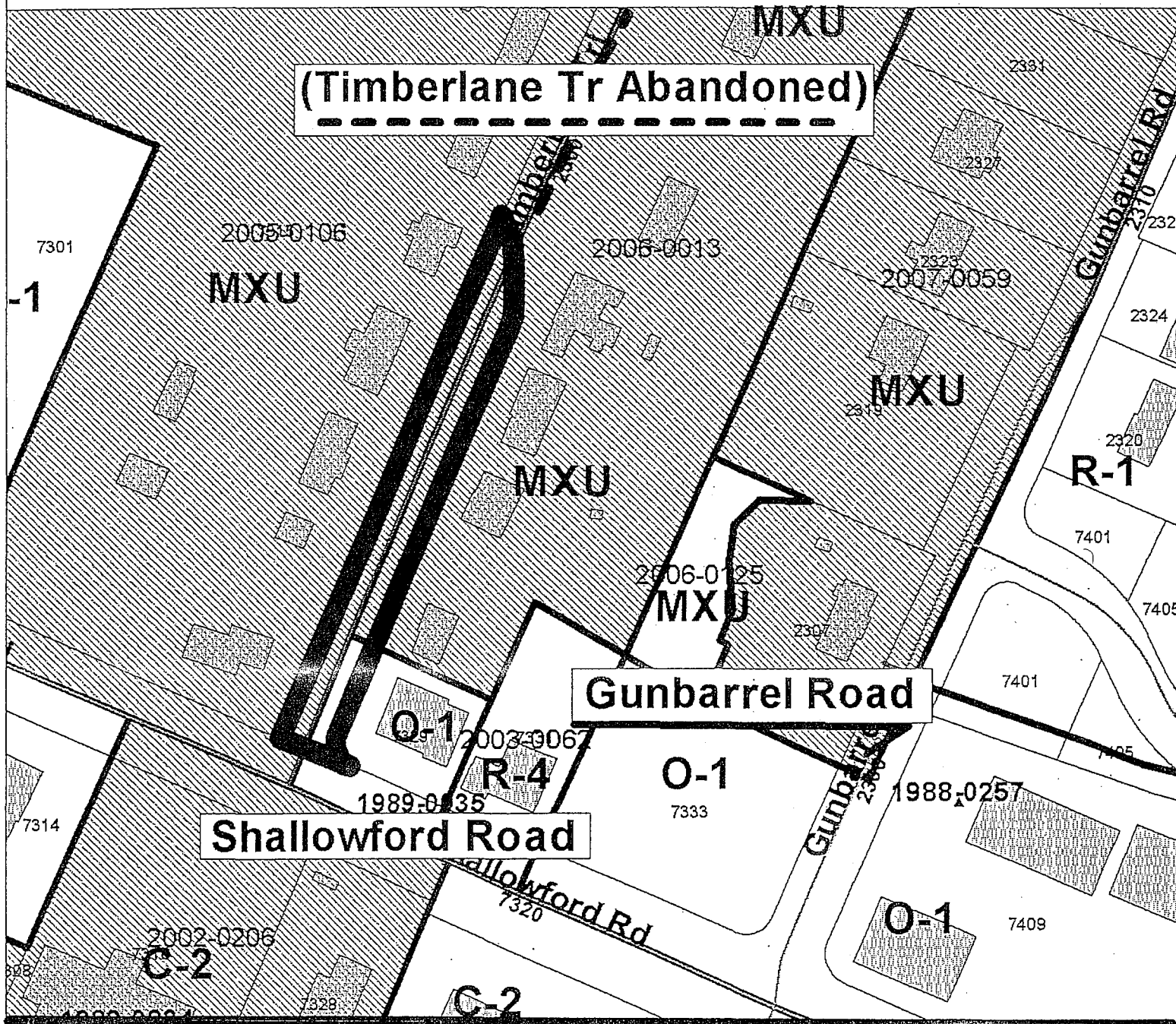
