ORDINANCE NO. 12360

AN ORDINANCE TO AMEND CHATTANOOGA CITY CODE, PART II, CHAPTER 24, SECTION 24-304, RELATIVE TO PARKING FINES.

SECTION 1. BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHATTANOOGA, TENNESSEE, That Chattanooga City Code, Part II, Chapter 24, Section 24-304, be and is hereby amended by deleting same in its entirety and substituting in lieu thereof the following:

- (a) Any person parking in violation of a no parking sign or in a designated loading zone shall pay a fine of thirty-five dollars (\$35.00).
- (b) Any person parking in violation of any of the following shall pay a fine of fifty dollars (\$50.00):
 - (1) A designated bus zone;
 - (2) A designated fire lane;
 - (3) Within twenty-five (25) feet of a fire hydrant;
 - (4) Blocking an alley;
 - (5) A no parking zone during the hours of 7:00 a.m. to 9:00 a.m. and 4:00 p.m. to 6:00 p.m.
- (c) Any person who parks in violation of a thirty (30) minute restricted zone between the hours of 2:00 a.m. and 5:00 p.m. shall pay a fine of twenty dollars (\$20.00).
- (d) Unless otherwise specified, any person who parks in violation of any other provision of this Division of Article X shall pay a fine of thirty-five dollars (\$35.00). This provision shall not be construed to include Parking Meters, which are governed by Division 2 of Article X.
- (e) Any person cited for a violation as set out in paragraphs (a), (b), and (d) of this section shall pay such fine within seven (7) days to the city court clerk's office, either by mail or in person. If such fine is not paid within seven (7) days, a warrant may issue and the violator shall be subject to a fine of not less than thirty-five dollars (\$35.00) nor more than fifty dollars (\$50.00), plus court costs, which court costs shall not exceed thirty-one and 50/100 dollars (\$31.50) if both are paid before the court date.

(f) Any person cited for a violation as set out in paragraph (c) of this section shall pay such fine within seven (7) days to the city court clerk's office, either by mail or in person. If such fine is not paid within seven (7) days, a warrant may issue and the violator shall be subject to a fine of not less than twenty dollars (\$20.00) nor more than fifty dollars (\$50.00), plus court costs, which court costs shall not exceed thirty-one and 50/100 dollars (\$31.50) if both are paid before the court date.

SECTION 2. BE IT FURTHER ORDAINED, That this Ordinance shall take effect two
