Abandonment of an alley beginning at the west line of the 6000 block of Hall Road thence some 300 feet northwest to the east line of Tax Map 132H-A-014. Said alley separates Lots 99 from Lots 100 thru 102, W. L. Hall's Subdivision, Plat Book 14, Page 35, ROHC. Tax Map Nos. 132H-A-001 and 012 thru 014.

<u>SECTION 2</u>. BE IT FURTHER ORDAINED, That this closure and abandonment shall be subject to retention of all utility easements, routing rights, and right of ingress/egress.
