

ORDINANCE NO. <u>12555</u>

AN ORDINANCE REAPPORTIONING THE NINE DISTRICTS FOR THE CITY COUNCIL.

SECTION 1. BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHATTANOOGA, TENNESSEE, that the nine districts for the City Council be and are hereby reapportioned and redistricted as required following the 2010 census. The district boundaries are shown on the map incorporated herein. A digital version that provides map information in larger scale is on file in the Office of the City Court Clerk and is incorporated herein by reference. The statistical data for each district is set forth herein.
