## ORDINANCE NO. 12578

AN ORDINANCE TO AMEND CHATTANOOGA CITY CODE, PART II. CHAPTER 26, SECTION 26-23, ESTABLISHING THE EVENT FEES FOR USAGE OF VARIOUS CHATTANOOGA PARKS AND RECREATION FACILITIES AND ARTS AND CIVIC CENTERS.

WHEREAS, the Department of Parks and Recreation modified fees for the use of parks and recreation facilities set forth in Chattanooga City Code 26-23 by enactment of City of Chattanooga Ordinance No. 12569, enacted on February 14, 2012; and

WHEREAS, the Department of Education, Arts and Culture added new fees for the use of parks and recreation arts and civic center facilities to Chattanooga City Code 26-23 by enactment of City of Chattanooga Ordinance No. 12570, enacted on February 14, 2012; and,

WHEREAS, City of Chattanooga Ordinance No. 12570, enacted on February 14, 2012 superseded the fees and for the use of park and recreation fees enacted by Ordinance No. 12569; and,

WHEREAS, the operative date of the modified fees requested by the Departments of Parks and Recreation and new fees added by Education, Arts and Culture are effective as of the dates of Ordinance Numbers 12569 and 12570.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHATTANOOGA.
TENNESSEE:

SECTION 1. That Chattanooga City Code, Part II. Chapter 26. Section 26-23, amended by Chattanooga City Ordinance Numbers 12569 and 12570, be and the same is hereby deleted in its entirety and the following is substituted in lieu thereof:

- (2) Written and documented agreements for volunteers to donate volunteer hours for the operation and maintenance of the Arts and Culture Civic Centers based on a rate of \$10.00 for each one (1) hour of documented volunteer service.

SECTION 3. BE IT FURTHER ORDAINED, That this Ordinance shall become effective immediately, but the effective date of the fee changes shall be retroactive to February 14, 2012, the date of Ordinance Numbers 12569 and 12570 from and after its passage.
