ORDINANCE NO. 12609

AN ORDINANCE TO AMEND ORDINANCE NO. 12534, ENTITLED "AN ORDINANCE APPROPRIATING, AUTHORIZING OR ALLOCATING FUNDS TO THE CAPITAL IMPROVEMENTS BUDGET FOR THE FISCAL YEAR 2011/2012" SO AS TO ACCEPT A TOTAL OF ONE HUNDRED SIX THOUSAND NINE HUNDRED NINETY-NINE AND 63/100 DOLLARS (\$106,999.63) FROM HAMILTON COUNTY, THE CHATTANOOGA HOUSING AUTHORITY, CITY OF COLLEGEDALE, CITY OF EAST RIDGE, CITY OF RED BANK, CITY OF SIGNAL MOUNTAIN, CITY OF SODDY-DAISY AND UNIVERSITY OF TENNESSEE AT CHATTANOOGA AND PROVIDE PRORATA SHARE FUNDING FOR THE VISIONAIR RMS/MOBILE SOFTWARE DATABASE APPLICATION UPGRADE.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHATTANOOGA, TENNESSEE:


