

ORDINANCE NO. 13164

AN ORDINANCE TO AMEND ORDINANCE NUMBER 10098 CLOSING AND ABANDONING VINE STREET LOCATED BETWEEN THE SOUTHEASTERN LINE OF DOUGLAS STREET AND THE NORTHWESTERN LINE OF PALMETTO STREET BETWEEN MCCALLIE AVENUE AND EAST 5<sup>TH</sup> STREET FOR THE UNIVERSITY OF TENNESSEE AT CHATTANOOGA.

SECTION 1. BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHATTANOOGA, TENNESSEE, That Ordinance Number 10098 be hereby amended to close and abandon Vine Street located between the Southeastern line of Douglas Street and the Northwestern line of Palmetto Street between McCallie Avenue and East 5<sup>th</sup> Street, being more particularly described as follows:

BEGINNING at the intersection of Vine Street right-of-way and the Southeastern right-of-way line of Douglas Street;

THENCE in a Southeastern direction with the 60 foot wide right-of-way of Vine Street a distance of 1,866.84 feet, more or less, between parallel lines to the Northwestern right-of-way line of Palmetto Street. Said right-of-way separates Lots A, I, J, K, M and T, Stapps Subdivision, not recorded, Lots 1 through 7 of Wyatt and Wight Subdivision as shown on plat of record in Plat Book 4, Page 48, R.O.H.C., the property as shown on Tax Map 146A, Group "B" being Parcel 001, Lots 1 through 12 - Loomis & Hart Subdivision as shown on plat of record in Plat Book 5, Page 14, R.O.H.C. - part of Lot H, A. K. Frazier's Subdivision, not recorded -Lot 1, UTC Engineering Block, Baldwin's Fortwood Addition as shown on plat of record in Plat Book 63, Page 157, R.O.H.C. - Lots 46 through 53 Fortwood Addition as shown on plat of record in Plat Book 1, Page 4, R.O.H.C. - Lots 14 through 20, Sims Subdivision, not recorded and an un-platted tract, as shown on the attached sketches.

Tax Map 145D, Group "G", Parcels 001, 005 & 006 - Tax Map 146A, Group "A", Parcels 001, 006, 029, 030, 030.1 & 031 - Tax

Map 146A, Group "B", Parcel 001 – Tax Map 146A, Group "C",  
Parcel 001 – Tax Map 146A, Group "F", Parcel 010.

SECTION 2. BE IT FURTHER ORDAINED, That this Ordinance Number 10098/1994-135 for the University of Tennessee at Chattanooga is subject to all stipulations as stated in said Ordinance.

SECTION 3. BE IT FURTHER ORDAINED, That this Ordinance shall take effect two (2) weeks from and after its passage.

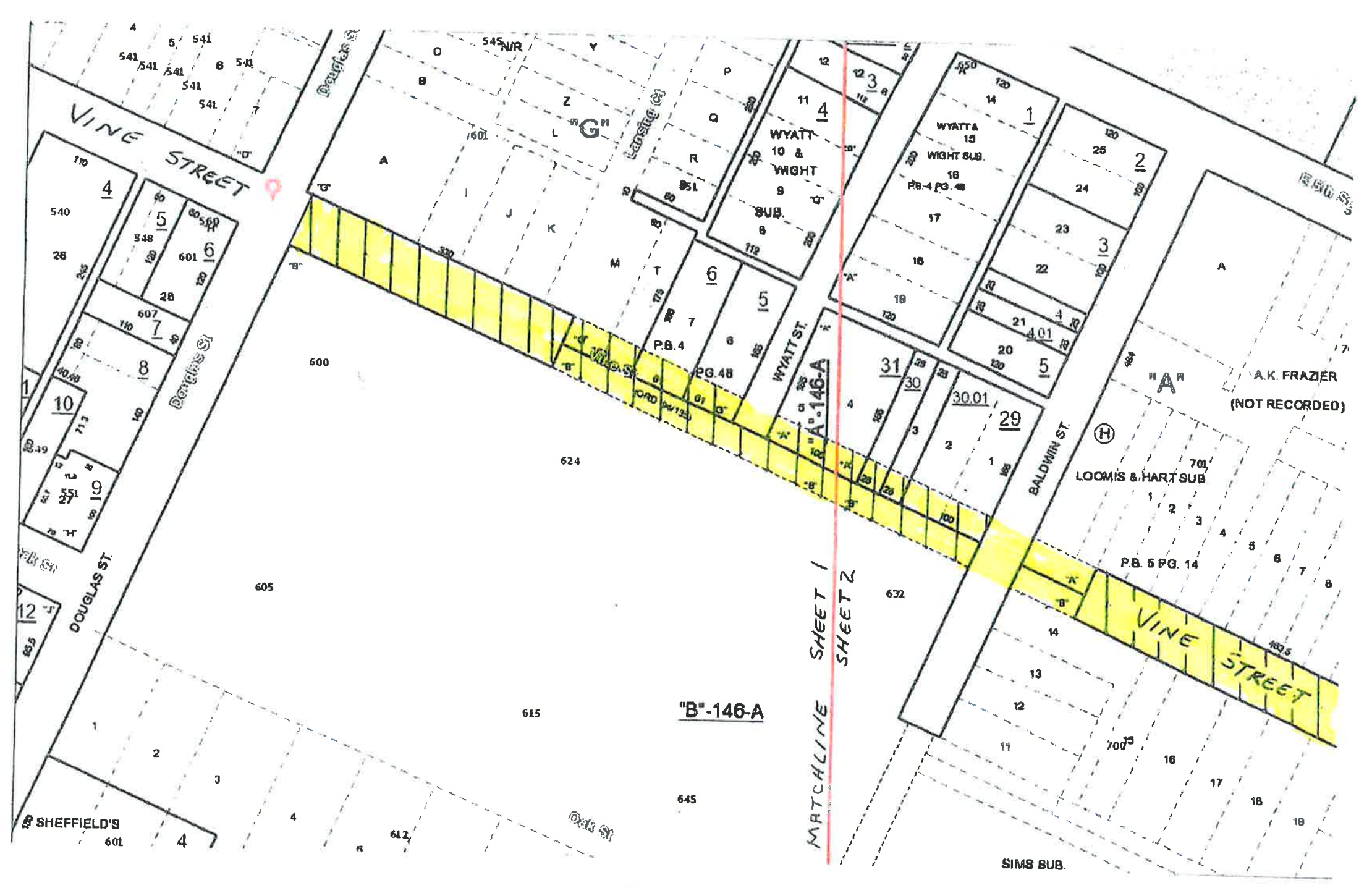

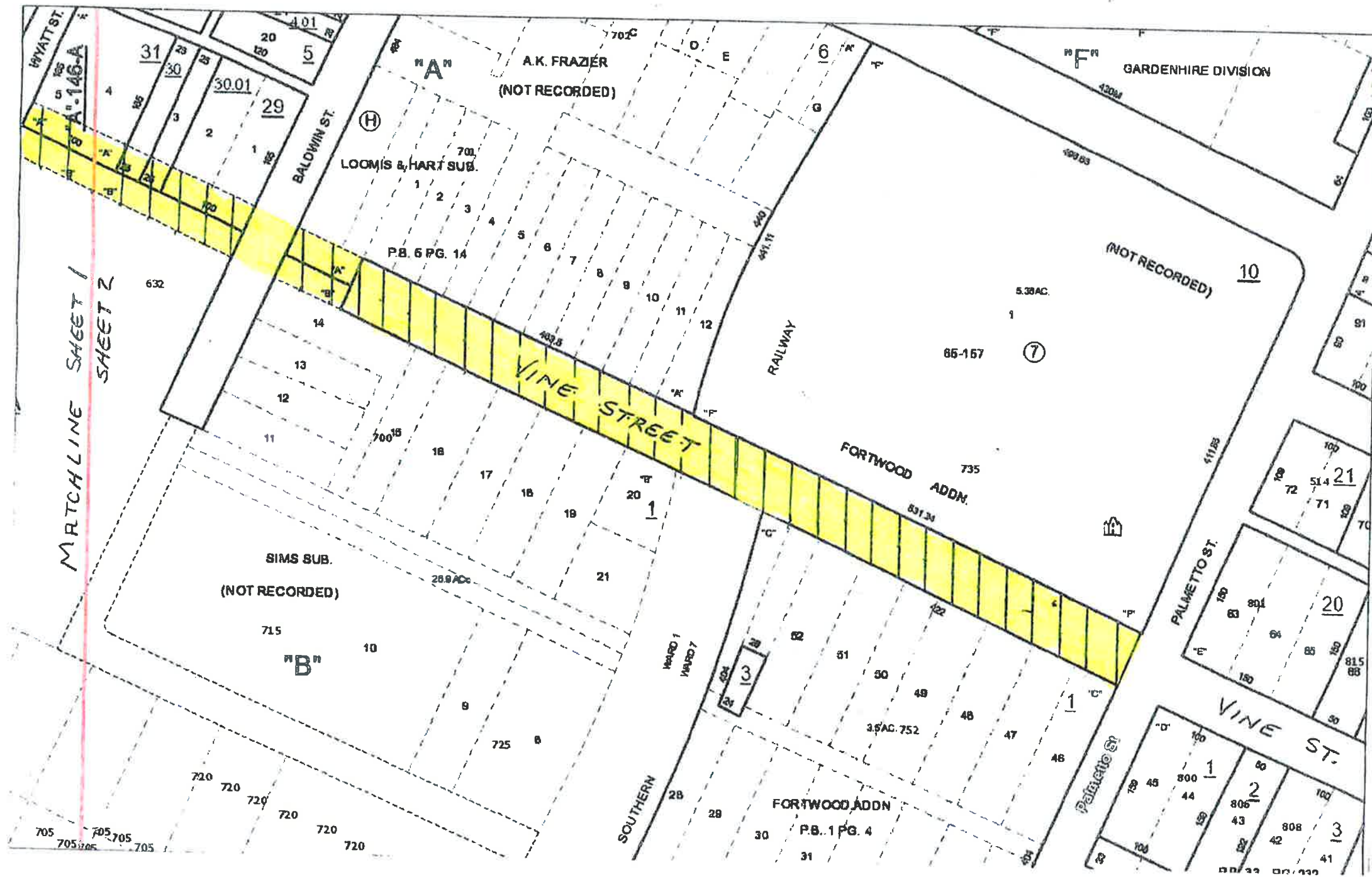
